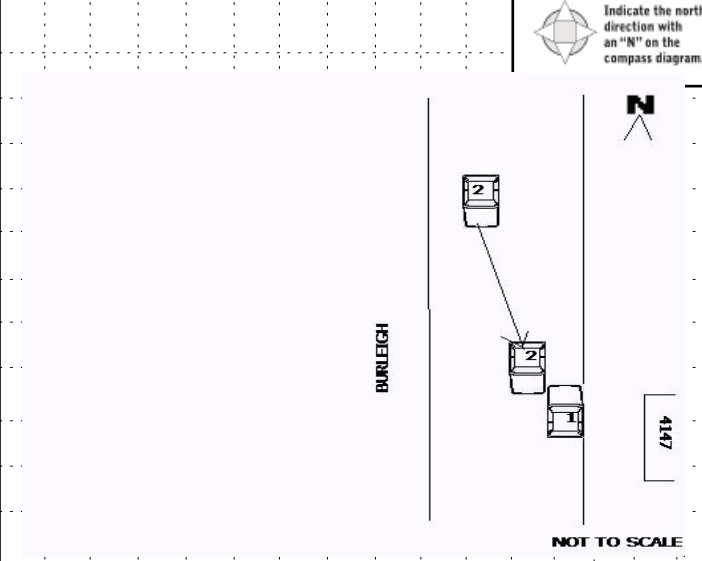

THE DRIVER OF UNIT #2 STATED THAT WHILE DRIVING, HE WAS EXPERIENCING A MEDICAL EMERGENCY, CAUSING HIM TO FEEL FAINT AND HIS VISION TO BLUR. GARFIELD HEIGHTS SQUAD #1 ARRIVED TO EVALUATE THE DRIVER OF UNIT #2 AND CLEARED HIM MEDICALLY.

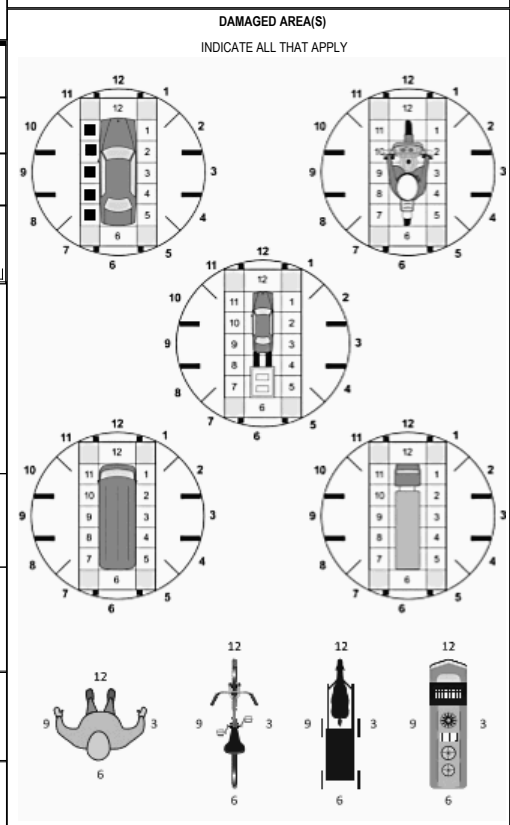

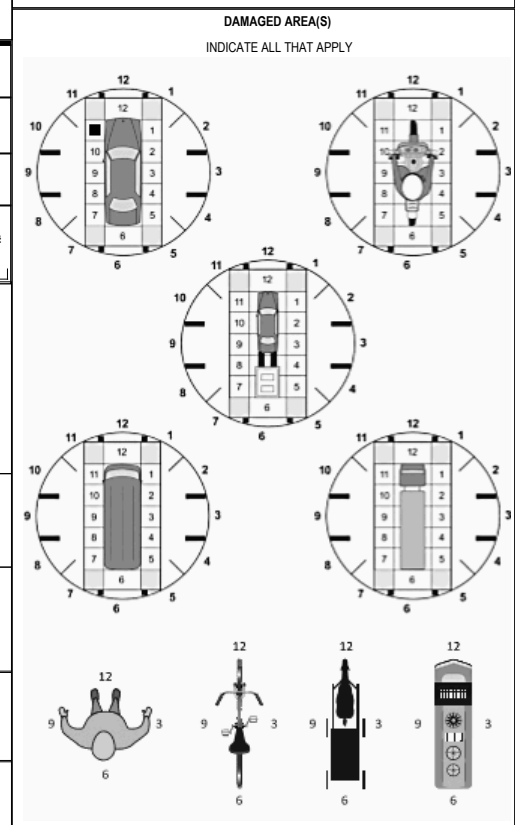
