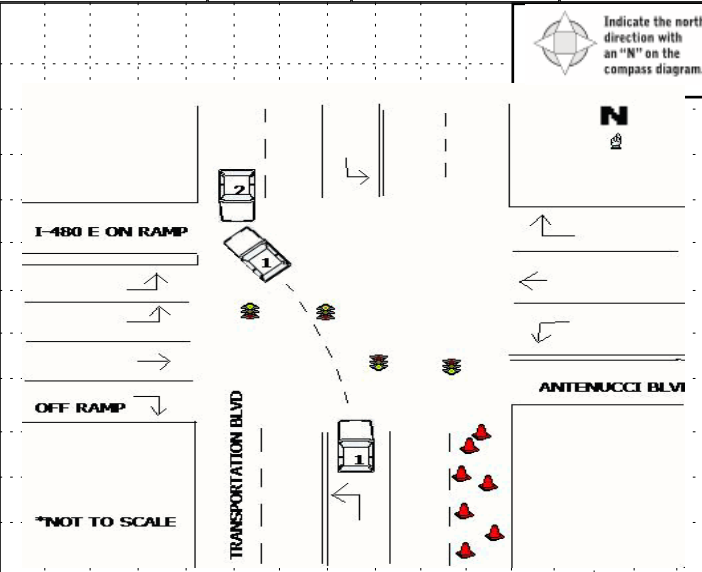

NARRATIVE
 BOTH DRIVERS CAME TO THE POLICE STATION TO REPORT THE FOLLOWING CRASH: UNIT 1 WAS TRAVELING N/B ON TRANSPORTATION BLVD AND BEGAN TO MAKE A LEFT TURN ONTO THE I-480 E ON RAMP. UNIT 2 WAS TRAVELING S/B ON TRANSPORTATION IN THE RIGHT LANE. UNIT 1 FAILED TO YIELD TO UNIT 2 AND UNIT 2 STRUCK UNIT 1 IN THE INTERSECTION. BOTH DRIVERS AGREED THAT THE TRAFFIC SIGNAL WAS GREEN FOR TRANSPORTATION BLVD. NO INJURIES REPORTED.
