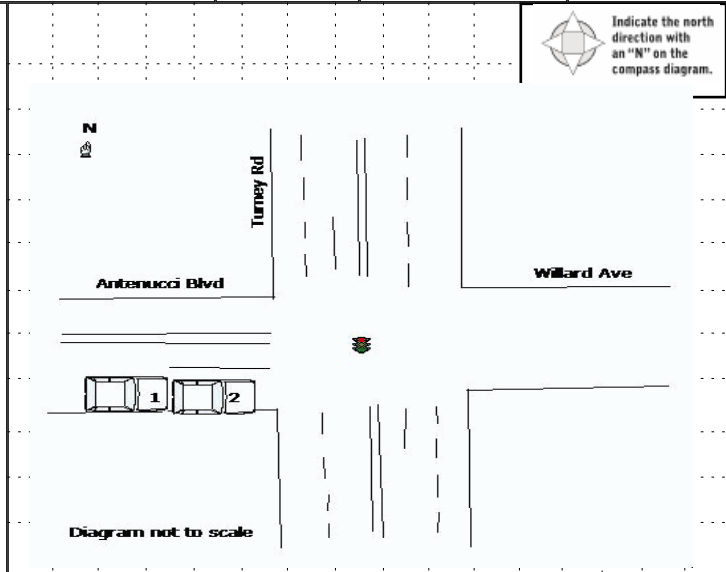

NARRATIVE

UNIT 2 WAS STOPPED IN THE EASTBOUND LANE OF ANTENUCCI BLVD AT A RED LIGHT. UNIT 2 WAS WAITING FOR TRAFFIC TO CLEAR BEFORE PROCEEDING TO MAKE A RIGHT TURN ONTO TURNEY RD. UNIT 1 WAS TRAVELING BEHIND UNIT 2. THE DRIVER OF UNIT 1 STATED HIS VEHICLE SLID ON A PATCH OF ICE ON THE ROADWAY AND STRUCK UNIT 2. THE DRIVER OF UNIT 2 WAS COMPLAINING ABOUT BEING SORE BUT DECLINED MEDICAL ATTENTION. BOTH UNITS SUSTAINED FUNCTIONAL DAMAGE.
