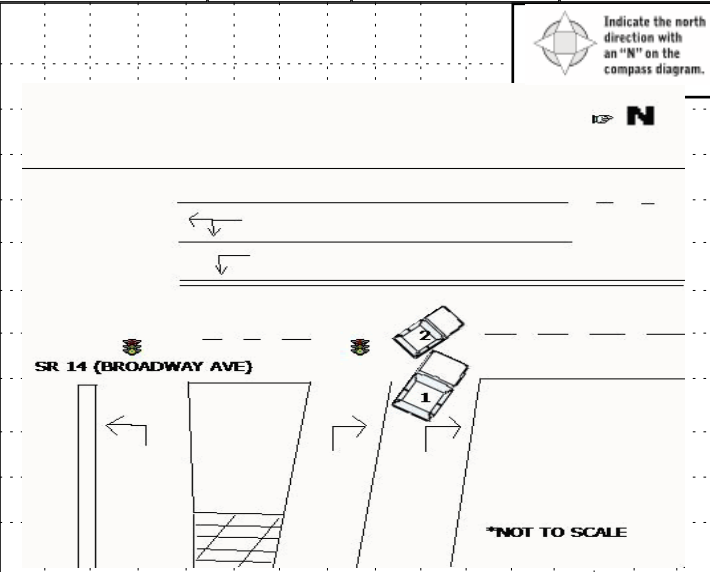

 UNITS 1 & 2 WERE TURNING RIGHT ONTO SR 14 (BROADWAY AVE) FROM THE I-480 OFF RAMP. THERE ARE TWO RIGHT TURN ONLY LANES. UNIT 1 WAS IN THE RIGHT LANE AND UNIT 2 WAS IN THE LEFT LANE. DURING THE COURSE OF THE RIGHT TURN, BOTH UNITS COLLIDED. BOTH DRIVERS STATED THAT THEY STAYED IN THEIR TRAFFIC LANES AND THERE WERE NO INDEPENDENT WITNESSES. UNKNOWN WHICH UNIT CAUSED THE CRASH.

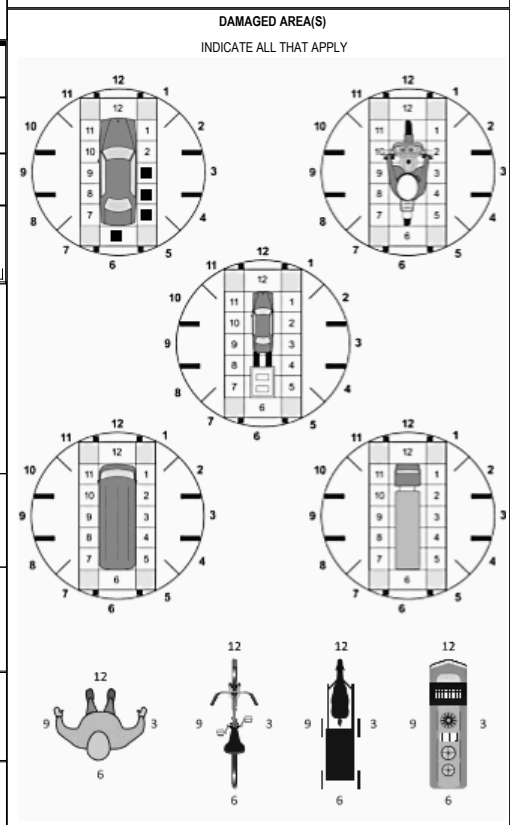
