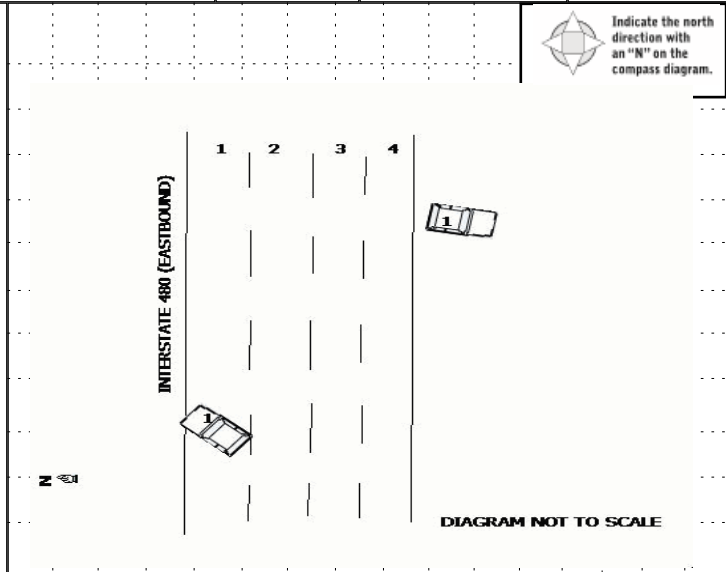

NARRATIVE

UNIT 1 WAS TRAVELING EASTBOUND ON I-480. THE DRIVER STATED HE WAS FATIGUED FROM WORKING A LOT OF HOURS THE PAST FEW DAYS. THE DRIVER STATED HE FELL ASLEEP AT THE WHEEL AND WOKE UP AFTER THE COLLISION. EVIDENCE FROM THE SCENE SHOWED UNIT 1 TRAVELING OFF THE ROADWAY AND STRIKING THE MEDIAN CONCRETE BARRIER. UNIT 1 THEN TRAVELED ACROSS ALL LANES OF TRAFFIC AND CAME TO FINAL REST IN THE GRASS ON THE SOUTH SIDE OF THE ROADWAY.

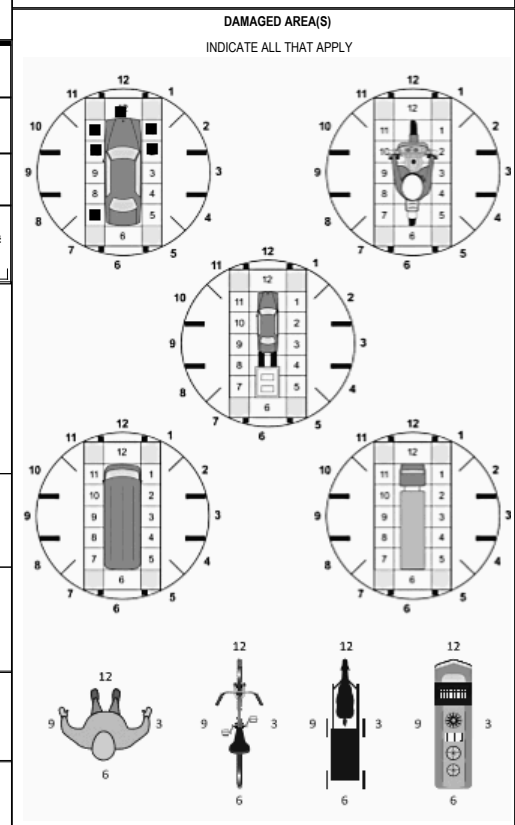
