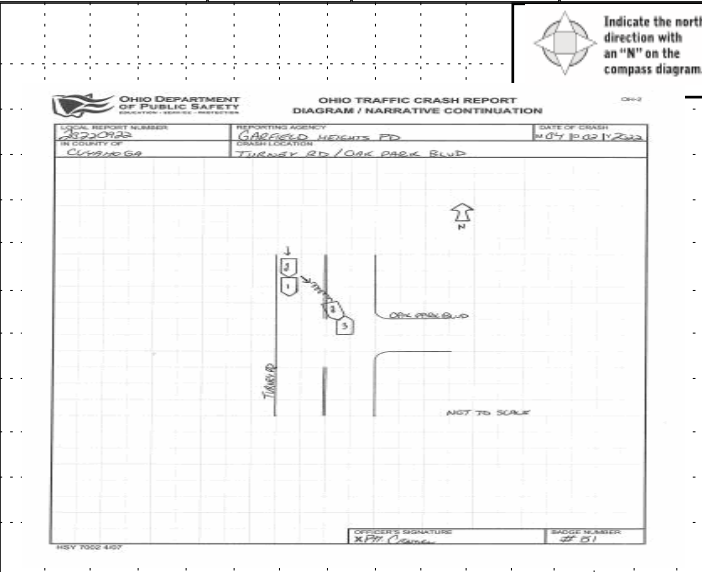

NARRATIVE
 UNIT 1 AND UNIT 2 WERE TRAVELING SOUTHBOUND ON TURNEY RD. UNIT 1 CHANGED LANES INTO THE CURB LANE TO AVOID A VEHICLE TURNING LEFT. UPON FURTHER REVIEW OF SURVEILLANCE FOOTAGE, UNIT 1 DID NOT APPEAR TO COMMIT FULLY TO CHANGING LANES AND STOPPED IN BETWEEN BOTH SOUTHBOUND LANES OF TRAVEL. UNIT 2 STRUCK UNIT 1 IN THE CURB LANE THEN LOST CONTROL TRAVELING INTO ONCOMING TRAFFIC. UNIT 2 STRUCK UNIT 3 HEAD ON CAUSING BOTH TO COME TO REST ON THE EAST SIDE OF THE ROADWAY.

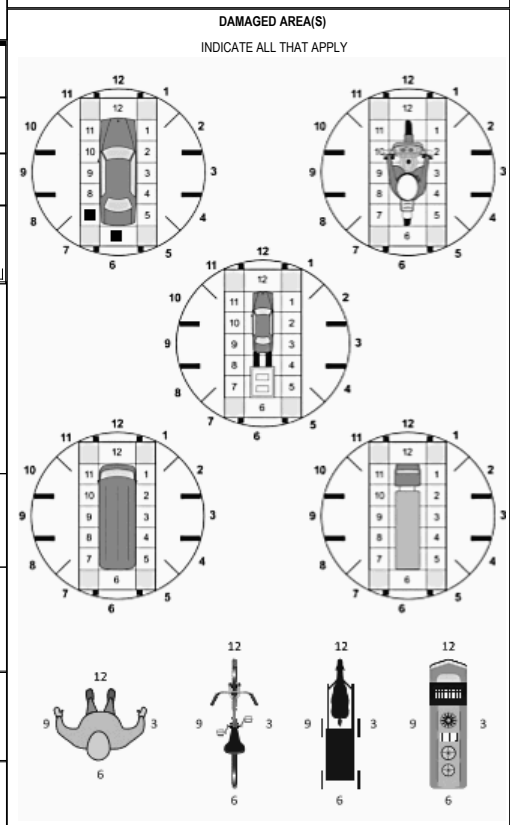

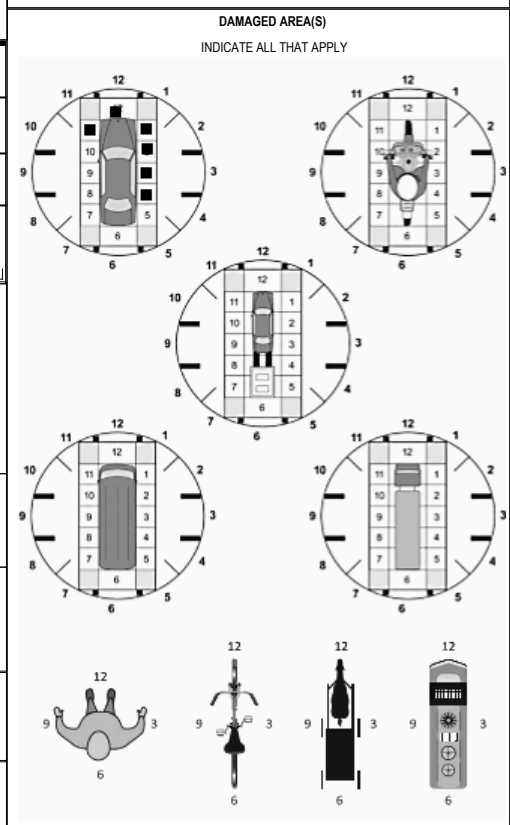

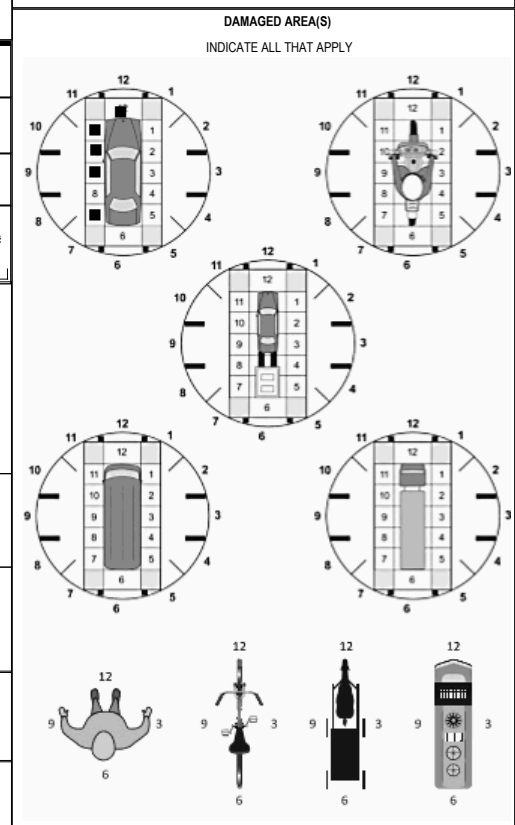
