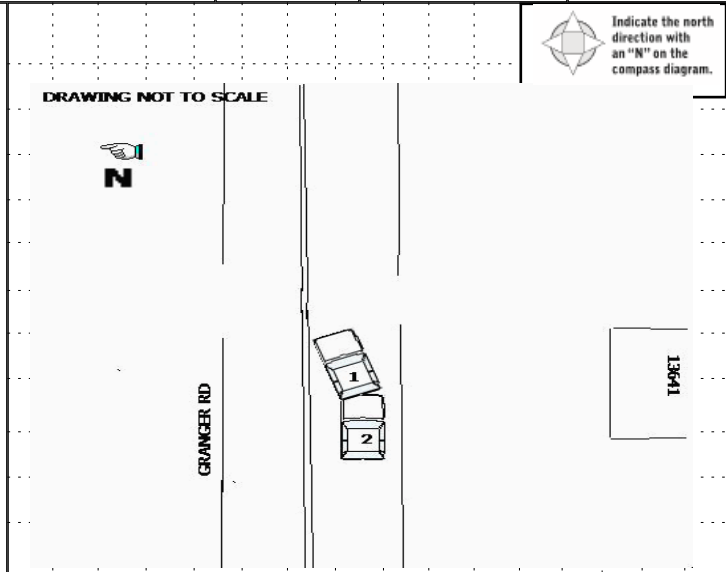

 UNIT 1 WAS TRAVELING EASTBOUND ON GRANGER RD NEAR 13641 GRANGER STOPPED TO MAKE A LEFT TURN AND WAS STRUCK BY UNIT 2 . THE DRIVER OF UNIT 2 STATED HE WAS TRAVELING EAST ON GRANGER BEHIND UNIT 1 WHEN UNIT 1 STARTED TO MAKE A LEFT TURN AND STOPPED MID TURN AND HE WAS UNABLE TO STOP STRIKING UNIT 1 . THE DRIVER OF UNIT 1 LEFT THE SCENE WITHOUT IDENTIFYING HIMSELF AND ONLY LEFT INSURANCE INFORMATION . OFFICER MARKS MADE SEVERAL ATTEMPTS TO CONTACT THE OWNER OF UNIT 1 WITH NEGATIVE RESULTS .

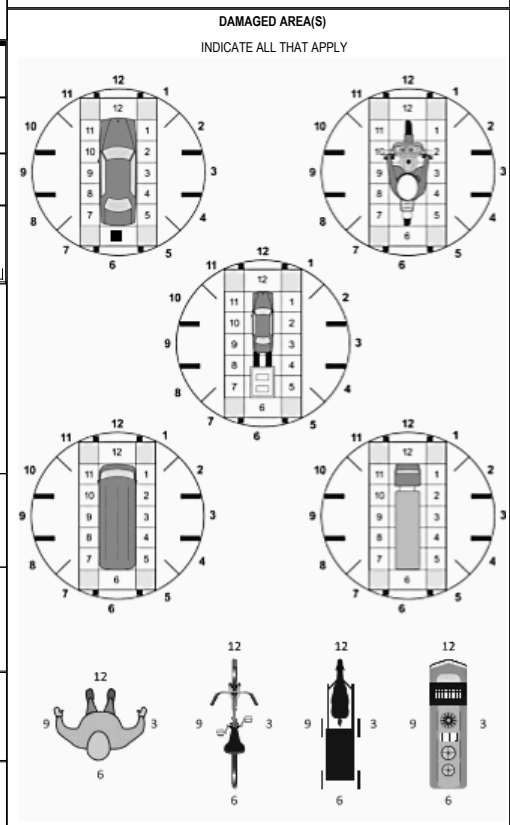

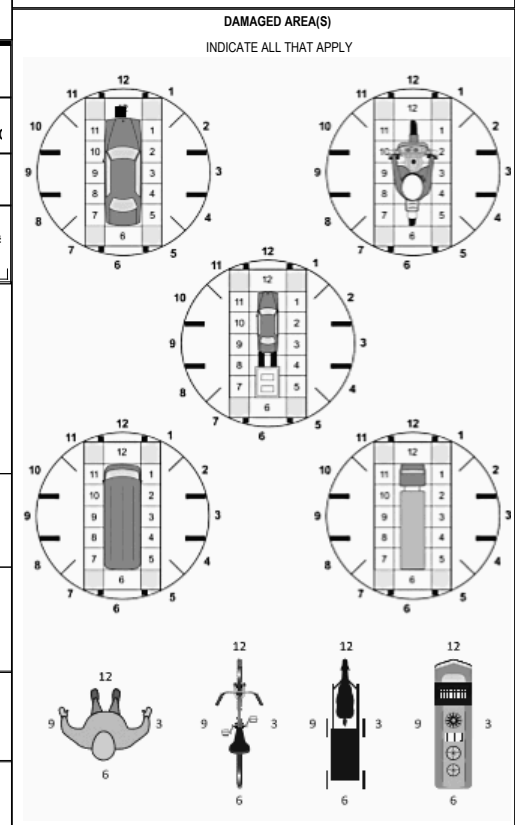
