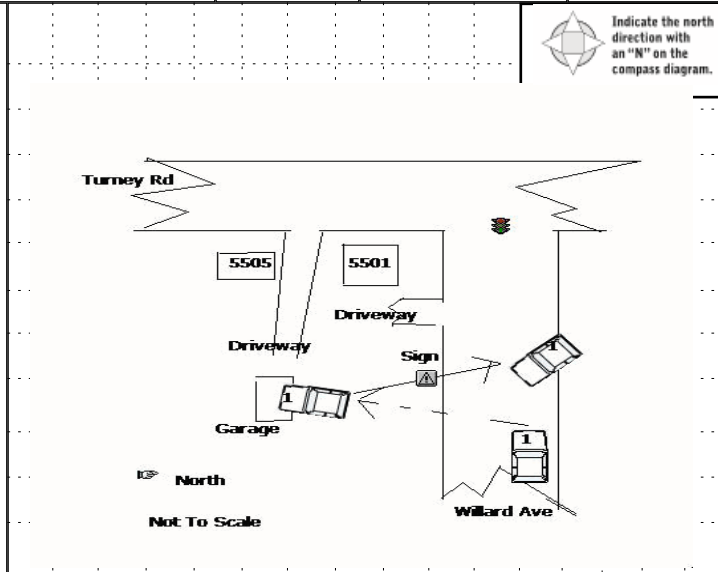

UNIT # 1 CONTINUED IN A SOUTHERN DIRECTION THROUGH THE YARD OF 5501 TURNEY. AS UNIT # 1 CONTINUED SOUTHBOUND, THE FRONT COLLIDED WITH A GARAGE AT 5505 TURNEY. UNIT # 1 THEN BACKED IN A NORTHERN DIRECTION AND ROLLED OVER A SIGN POST COMING TO FINAL REST AGAINST THE NORTH CURB OF WILLARD AVE FACING SOUTH UPON ARRIVAL. NOTE: SEE OH-2
