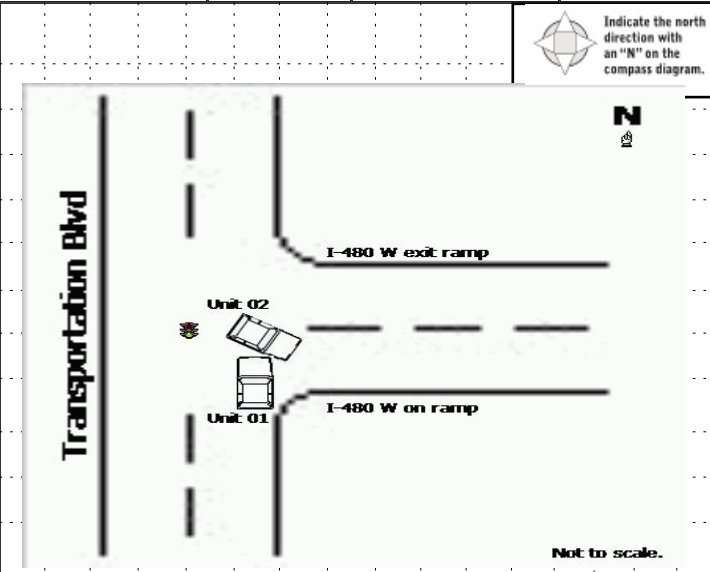

UNIT 02 WAS TRAVELING SOUTH ON TRANSPORTATION BLVD ATTEMPTING TO MAKE A LEFT/EAST TURN ONTO THE I-480 W ON RAMP WITH A GREEN LIGHT. UNIT 02 FAILED TO YIELD, AND TURNED IN FRONT OF UNIT 01. THE FRONT RIGHT OF UNIT 01 THEN STRUCK THE RIGHT SIDE OF UNIT 02.

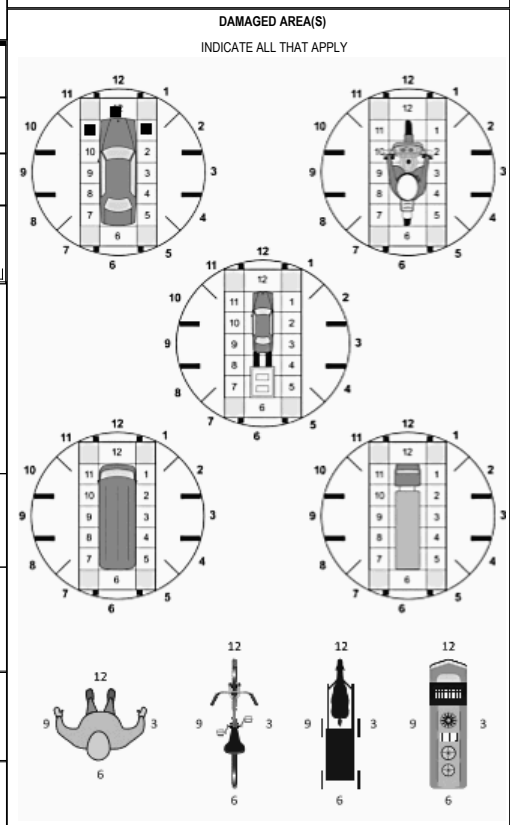
