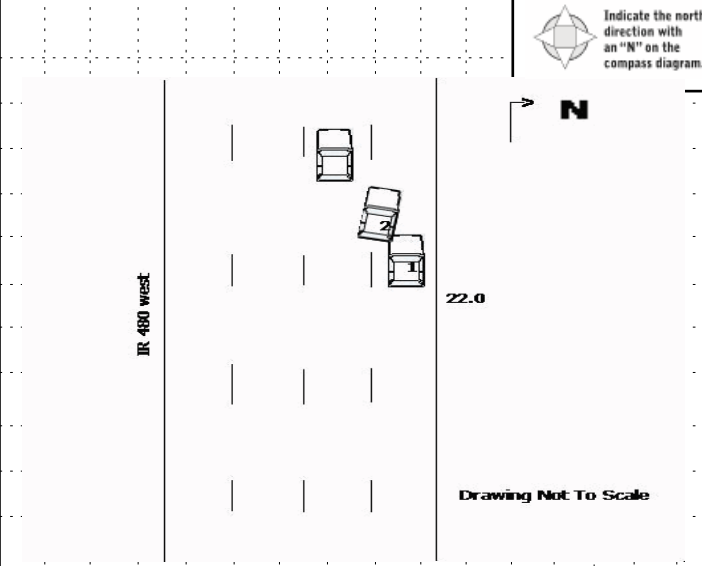

 UNIT 1 WAS TRAVELING IN THE FAR RIGHT LANE, WESTBOUND ON IR480 AT MILEPOST 22.0. UNIT 2 WAS TRAVELING AT A HIGH RATE OF SPEED IN THE INNER RIGHT LANE ON IR480 WESTBOUND AT 22.0. UNIT 2 MADE AN ILLEGAL LANE CHANGE INTO THE FAR RIGHT LANE, STRIKING UNIT 1, THEN MADE AN ILLEGAL LANE CHANGE BACK INTO THE INNER RIGHT LANE TO PASS A THIRD VEHICLE THAT WAS INITIALLY IN FRONT OF UNIT 2. UNIT 2 CONTINUED WESTBOUND ON IR 480. UNIT 1 SPUN OUT ON THE ROAD TO THE RIGHT, STRIKING THE GUARD RAIL.

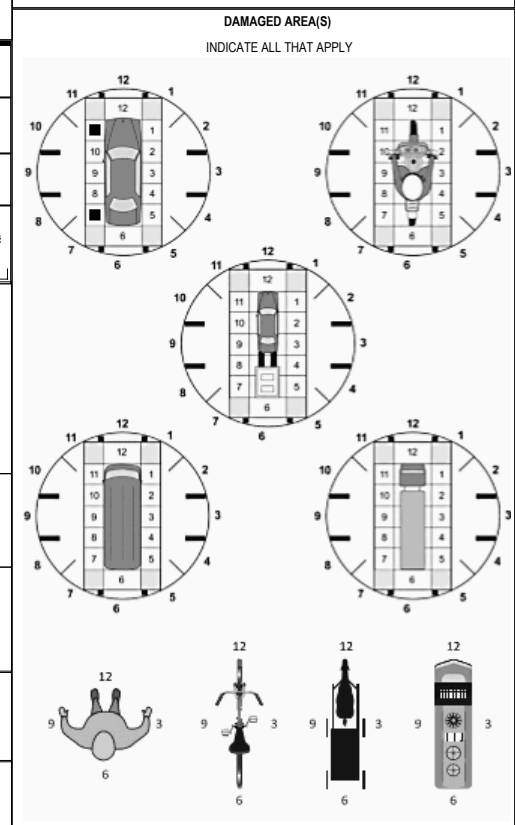

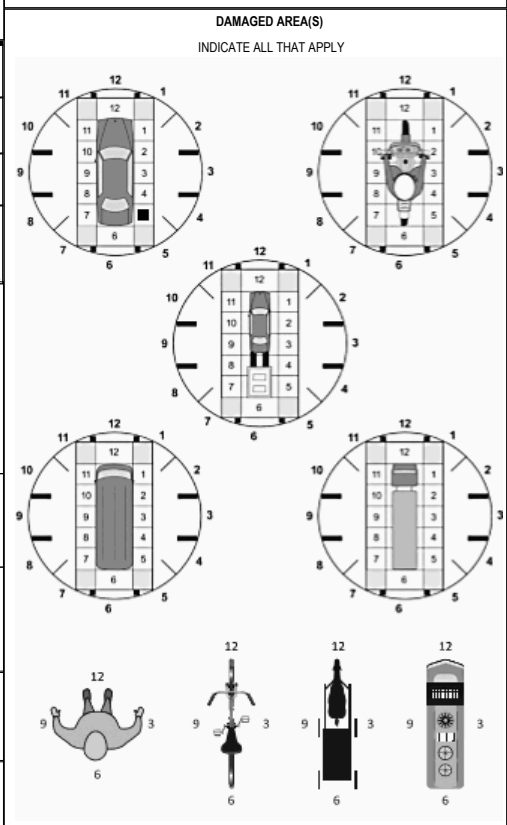
