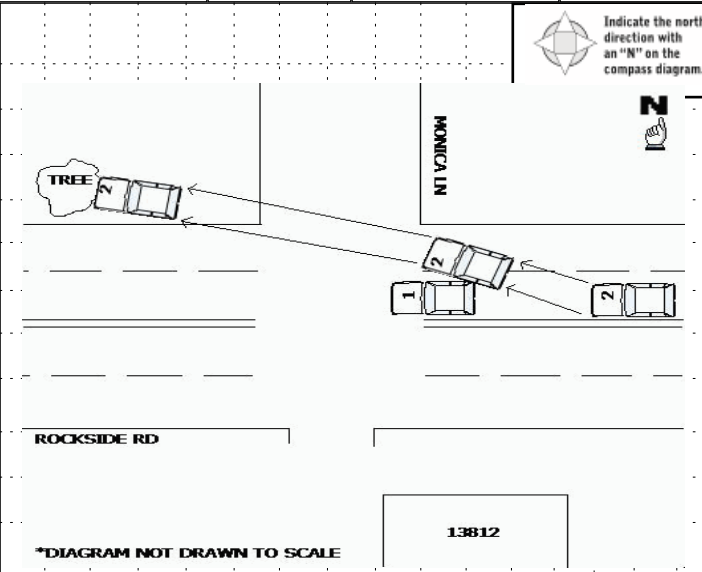

 UNIT 1 WAS STOPPED IN THE LEFT LANE OF W/B ROCKSIDE PREPARING TO TURN LEFT INTO THE DRIVEWAY OF 13812 ROCKSIDE. UNIT 2 WAS TRAVELING IN THE SAME LANE APPROACHING UNIT 1. THE OPERATOR OF UNIT 2 OPENED THE DRIVER DOOR TO DISCARD AN ITEM WHILE UNIT 2 WAS IN MOTION. DUE TO INATTENTION, UNIT 2 FAILED TO NOTICE UNIT 1 CAUSING UNIT 2 TO SWERVE TO THE RIGHT TO AVOID UNIT 1. THE OPEN DRIVER DOOR OF UNIT 2 STRUCK THE RIGHT REAR OF UNIT 1. UNIT 2 THEN TRAVELED OFF OF THE ROAD TO THE RIGHT AND STRUCK A TREE.

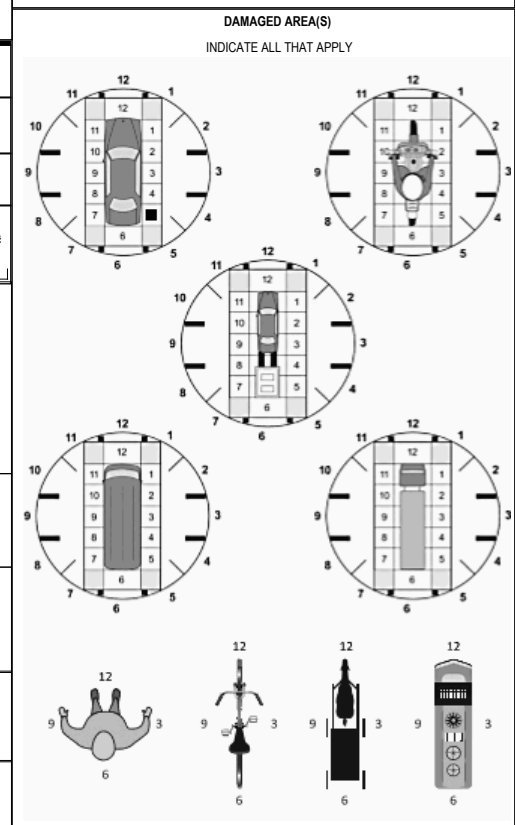

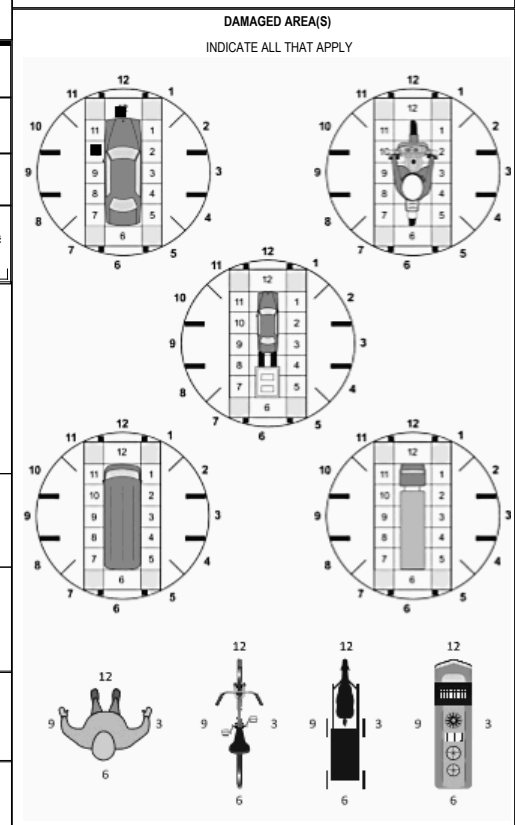
