THIS OFFICER SPOKE WITH DRIVER OF UNIT 2 AT HIS RESIDENCE. HE STATED THE FOLLOWING: UNIT 2 WAS TRAVELING E/B ON SR 14 (BROADWAY AVE) IN THE RIGHT LANE. UNIT 1 WAS TRAVELING E/B ON SR 14 IN THE LEFT LANE AND BEGAN TO DRIVE INTO THE RIGHT LANE, BUT FAILED TO YIELD TO UNIT 2, WHICH HAD THE RIGHT OF WAY. UNIT 1 STRUCK LEFT SIDE OF UNIT 2 AND FAILED TO STOP AFTER THE CRASH AND FLED THE SCENE. NO INJURIES REPORTED.

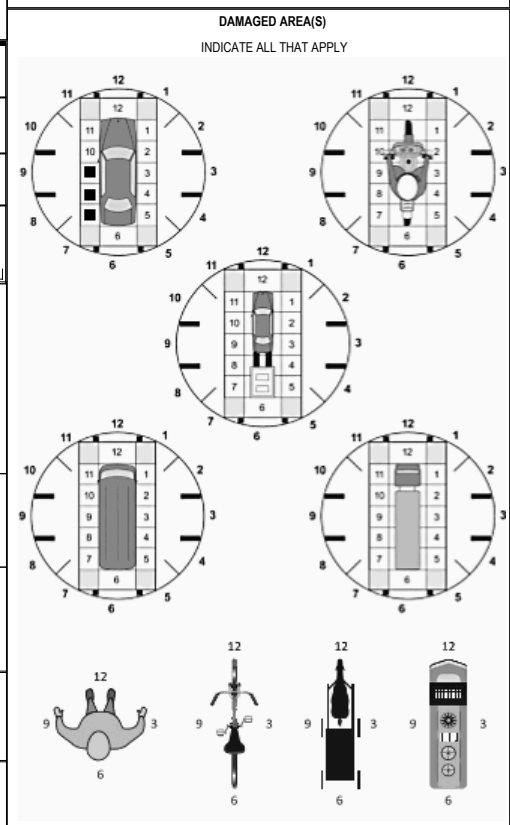
