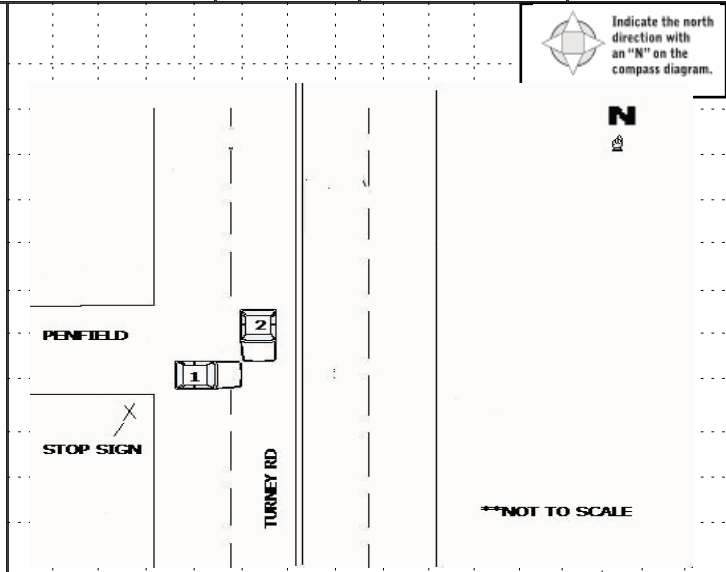

UNIT 1 STOPPED AT THE STOP SIGN E/B ON PENFIELD AVE AT TURNEY RD. UNIT 1 THEN DROVE STRAIGHT ONTO TURNEY RD AND FAILED TO YIELD TO UNIT 2, WHICH WAS TRAVELING S/B ON TURNEY RD IN THE LEFT LANE. UNIT 2 STRUCK THE LEFT FRONT AREA OF UNIT 1 AS UNIT 1 ENTERED THE LEFT TRAFFIC LANE ON TURNEY RD. DRIVER OF UNIT 1 STATED TRAFFIC WAS STOPPED IN THE RIGHT LANE AND SHE THOUGHT IT WAS CLEAR TO PASS. NO INJURIES REPORTED.

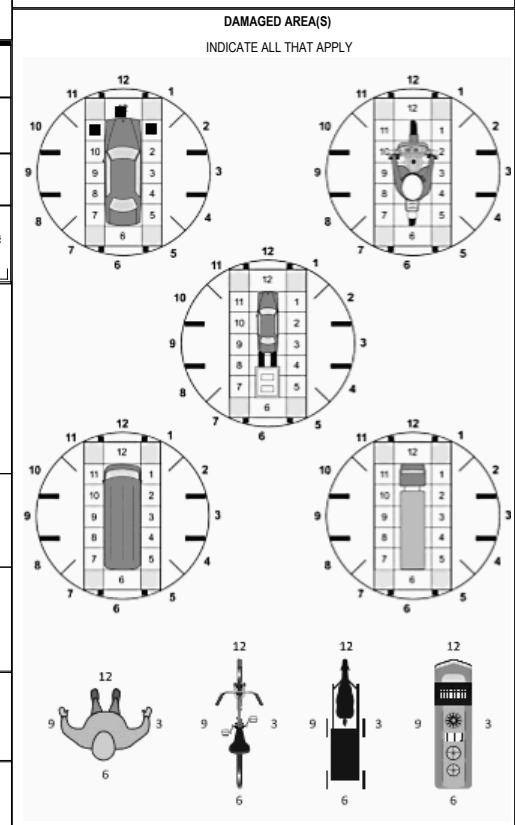
