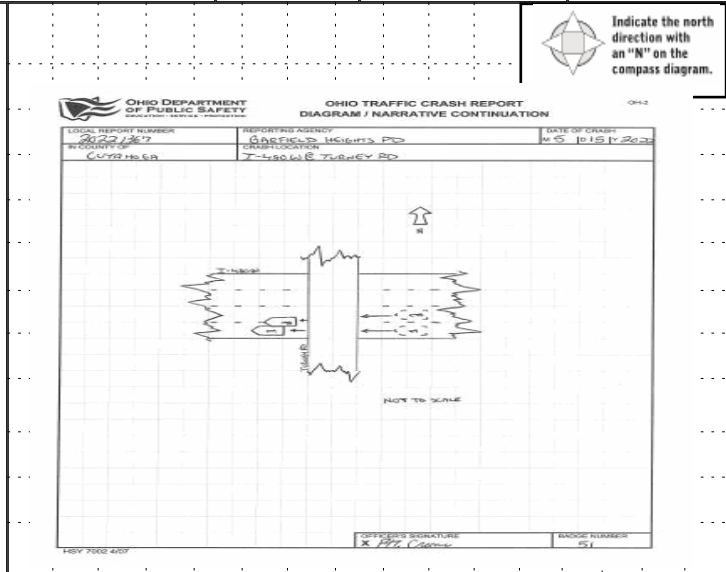

NARRATIVE

UNIT 1 WAS TRAVELING WESTBOUND ON INTERSTATE 480 IN THE NUMBER ONE LANE. UNIT 2 WAS TRAVELING WESTBOUND ON INTERSTATE 480 IN THE NUMBER TWO LANE. UNIT 2 MOVED INTO LANE NUMBER ONE AND STRUCK UNIT 1. THE DRIVER OF UNIT 2 PULLED OVER BRIEFLY BUT THEN DECIDED TO LEAVE THE SCENE PRIOR TO POLICE ARRIVAL. THE WITNESS WAS ABLE TO TAKE A CELL PHONE VIDEO AND CAPTURE THE LICENSE PLATE ON UNIT 2. NO INJURIES REPORTED AT THE SCENE.

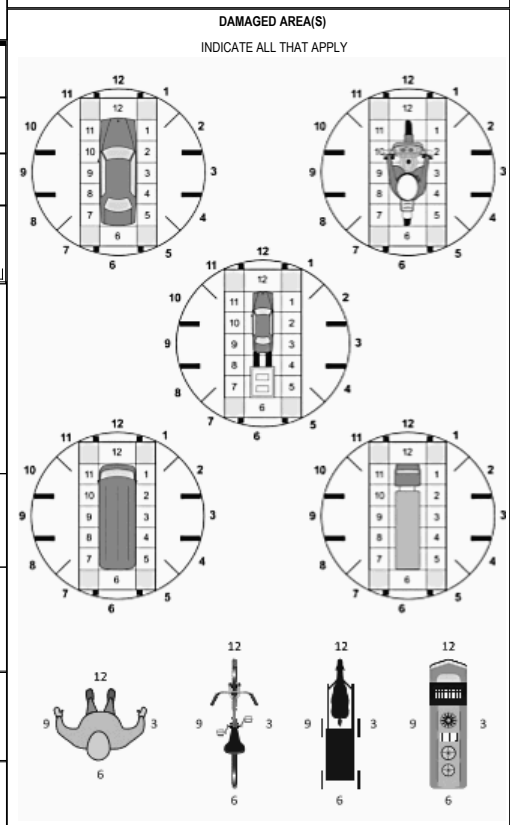
