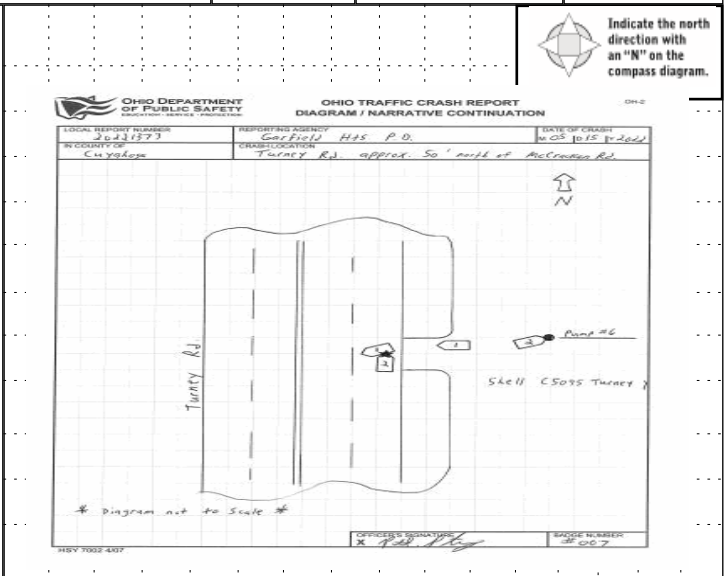

UNIT 1 WAS MAKING A LEFT TURN OUT OF THE PARKING LOT OF SHELL (5095 TURNEY RD). UNIT 2 WAS TRAVELING NORTHBOUND ON TURNEY RD IN THE CURB LANE. UNIT 1 FAILED TO YIELD TO UNIT 2 AND WAS CONSEQUENTLY STRUCK. AFTER STRIKING UNIT 1, UNIT 2 THEN TRAVELED A SHORT DISTANCE AND STRUCK A BARRIER AND PUMP #6 IN THE PARKING LOT OF SHELL. UNIT 2 CAME TO FINAL REST AGAINST PUMP #6. UNIT 1 CAME TO FINAL REST IN THE CURB LANE OF TURNEY RD.
