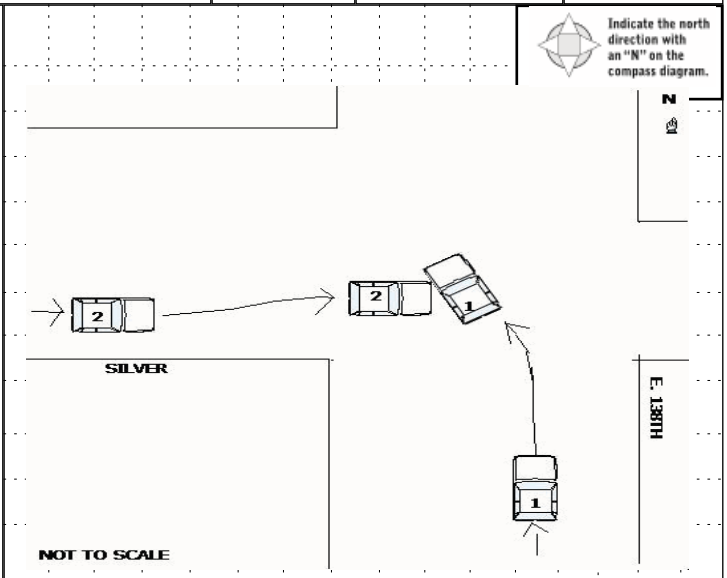

UNIT 1 WAS NORTH ON E. 138TH STREET AND THEN MADE A LEFT (WEST) TURN ON SILVER AFTER MAKING A COMPLETE STOP AT THE STOP SIGN. OPERATOR OF UNIT 1 STATED THAT UNIT 2 WAS TRAVELING EAST OF SILVER, FAILED TO STOP AT THE STOP SIGN, ENTERED THE INTERSECTION AND STRUCK THE LEFT SIDE OF UNIT 1 WITH THE CENTER FRONT OF UNIT 2. OPERATOR OF UNIT 2 FLED FROM THE AREA AFTER UNIT 1 REQUESTED HE PROVIDE HIS DRIVERS LICENSE. OPERATOR OF UNIT 2 WAS A BLACK MALE.

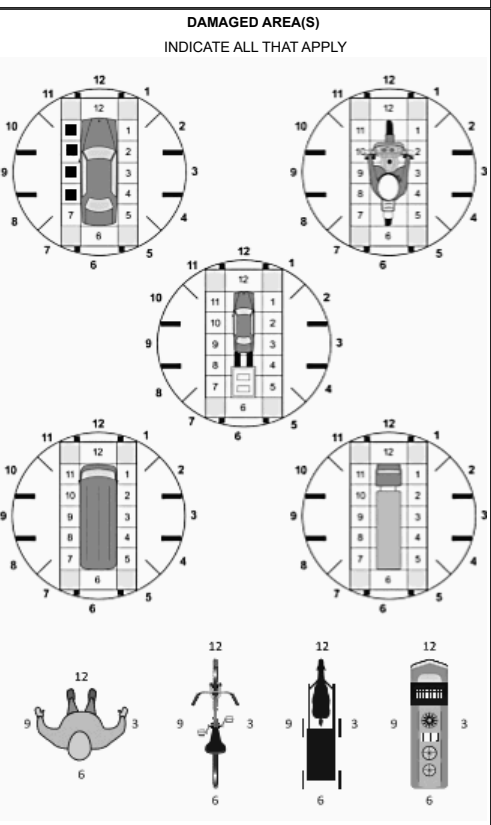
