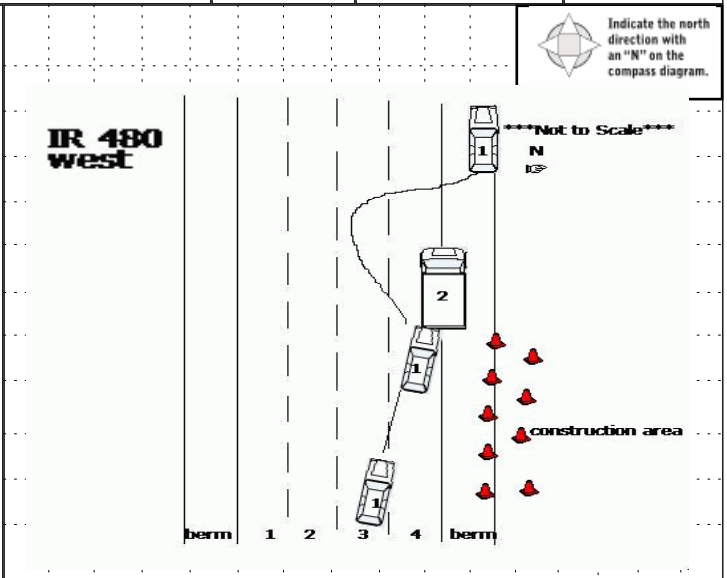

NARRATIVE

UNIT 2 WAS PARKED AND UNOCCUPIED ON I 480 WEST NEAR TRANSPORTATION BLVD, ACTING AS A SAFETY BARRIER TO PROTECT AN ALREADY ACTIVE CRASH SCENE. UNIT 1 WAS TRAVELING WEST BOUND ON I.480 AT A HIGH RATE OF SPEED, LOST CONTROL DUE TO THE HIGH SPEED CAUSING UNIT 1 TO TRAVEL OUTSIDE OF THE ROADWAY TO THE RIGHT AND STRIKE UNIT 2 IN THE LEFT REAR. UNIT 1 FLED THE SCENE AND WAS LATER APPREHENDED BY LAW ENFORCEMENT. OPERATOR OF UNIT 1 WAS FOUND TO BE OVI AND ARRESTED.
