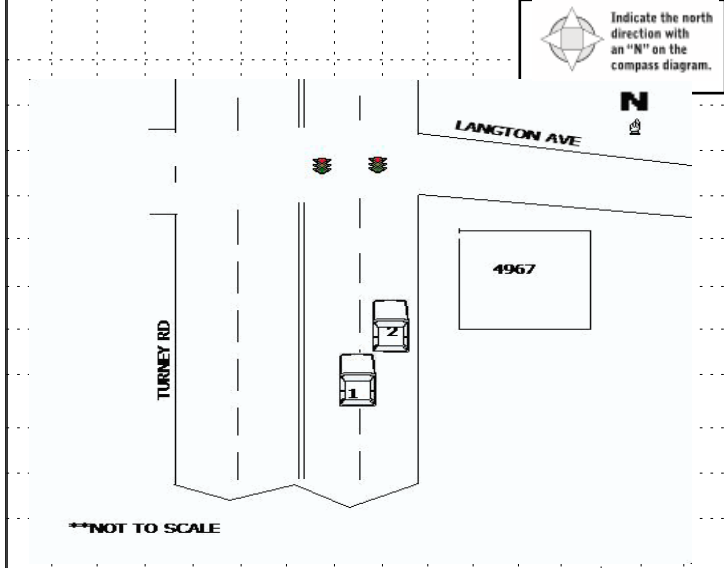

AT TURNEY RD AND RICHLAND AVE, UNIT 1 DROVE OVER THE CURB, DISABLING THE VEHICLE, AND THE DRIVER EXITED AND BEGAN WALKING AWAY FROM UNIT 1 S/B ON TURNEY RD. DRIVER WAS APPREHENDED BY GHPD OFFICERS AT TURNEY RD NEAR HOMEWORTH AVE. DRIVER OF UNIT 2 COMPLAINED OF POSSIBLE INJURY BUT DECLINED MEDICAL ATTENTION ON SCENE.

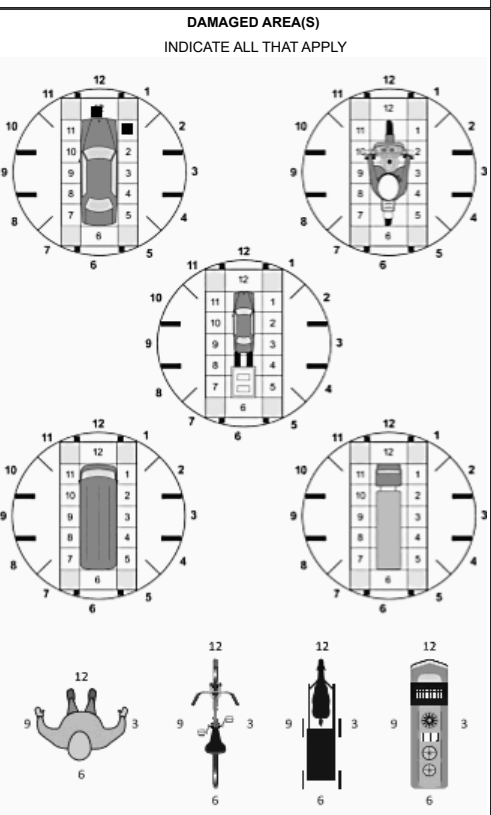
