

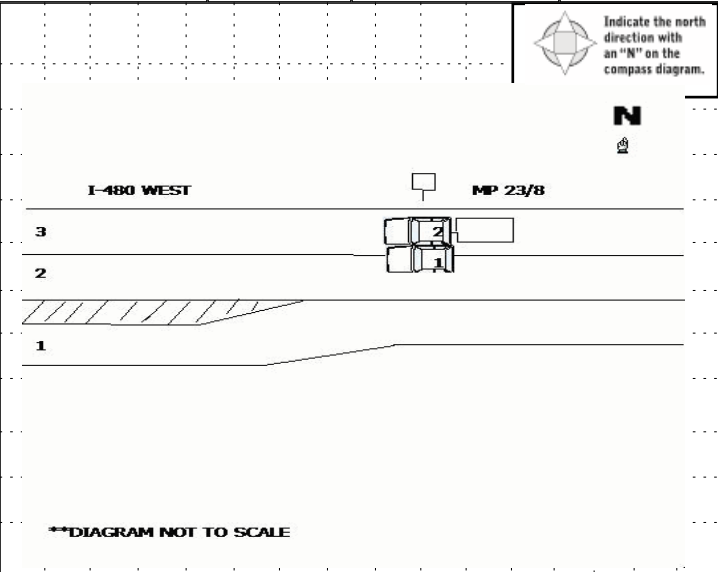

 UNITS 1 AND 2 WERE TRAVELING ON I-480 WEST NEAR MILE POST 23/8. UNIT 1 WAS IN LANE 2 AND DROVE INTO LANE 3 AND STRUCK THE LEFT SIDE OF UNIT 2, WHICH WAS IN LANE 3. NO INJURIES REPORTED. DRIVER OF UNIT 1 STATED THAT HE SNEEZED AND THAT CAUSED UNIT 1 TO DRIVE INTO LANE 3. BOTH UNITS STOPPED ON RIGHT SHOULDER AFTER THE CRASH.

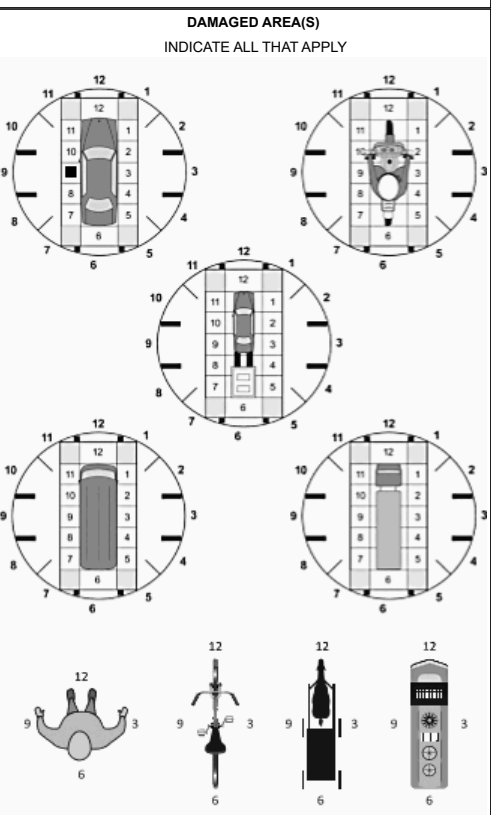
