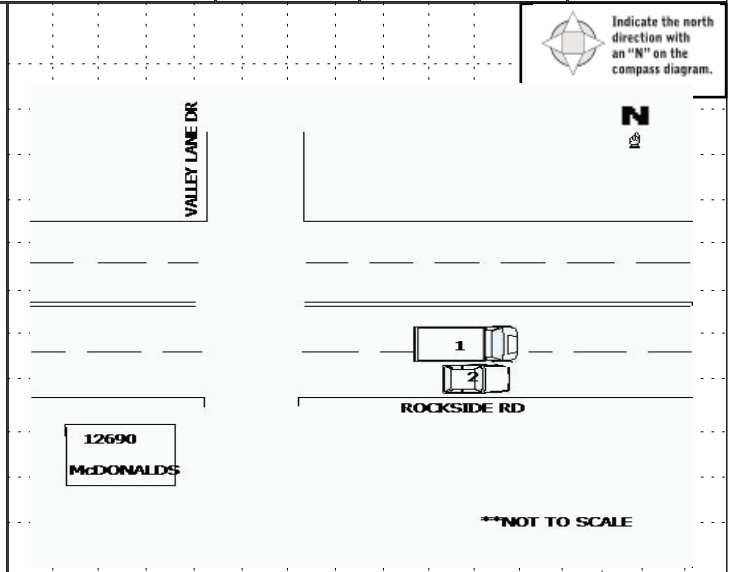

NARRATIVE

UNIT 1 WAS TRAVELING E/B ON ROCKSIDE RD IN THE LEFT LANE AND DROVE INTO THE CURB LANE AND STRUCK THE LEFT SIDE OF UNIT 2, WHICH WAS TRAVELING E/B IN THE RIGHT LANE. DRIVER OF UNIT 1 STATED ANOTHER VEHICLE CUT HIM OFF, CAUSING HIM TO DRIVE INTO THE RIGHT LANE AND HE WAS UNAWARE THAT HE EVEN STRUCK UNIT 2. BOTH VEHICLES PULLED INTO THE LOT OF 5571 TURNEY RD AFTER CRASH. NO INJURIES REPORTED.

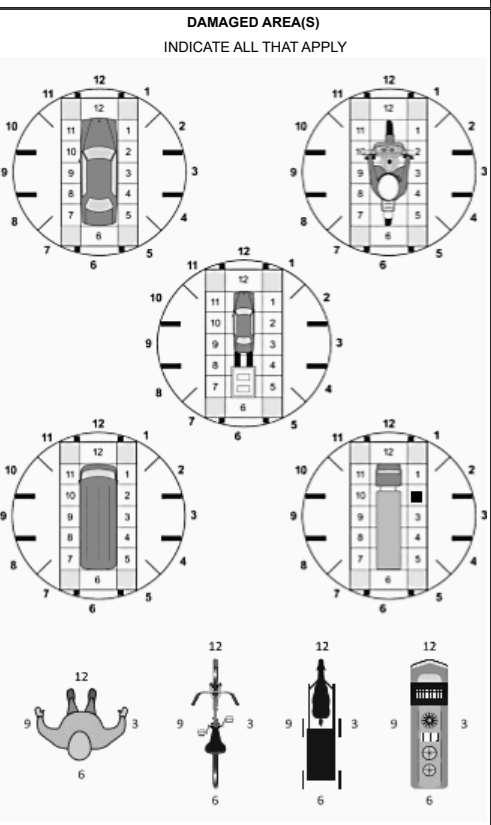

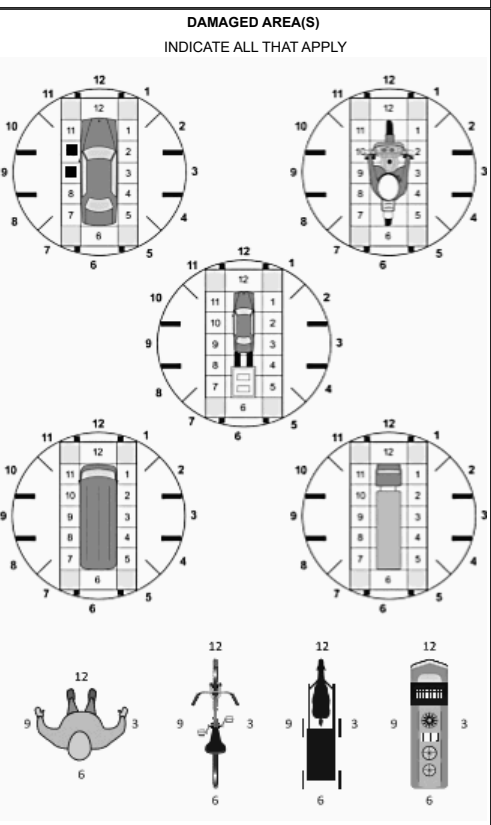
