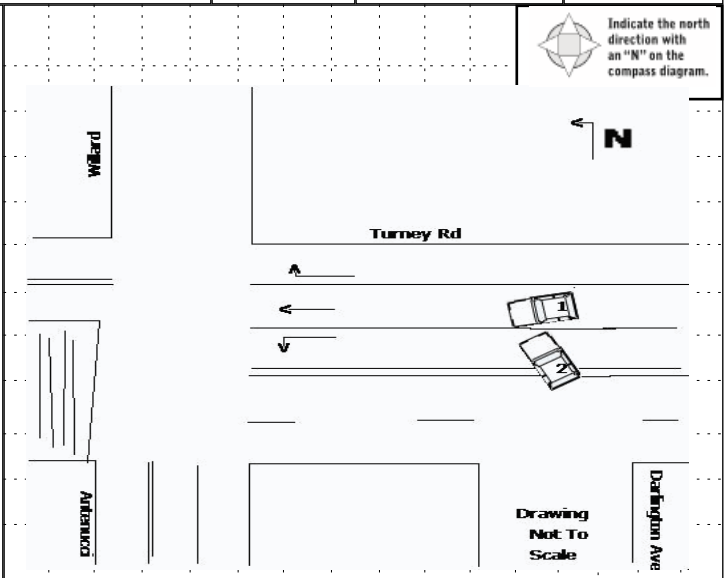

DRIVER OF UNIT 1 STATED THAT HE WAS TRAVELING NORTH ON TURNEY IN THE STRAIGHT LANE, AND BEGAN TO MERGE INTO THE TURNING LANE WHEN UNIT 2 EXITED DARLINGTON AND STRUCK UNIT 1. DRIVER OF UNIT 2 STATES THAT SHE TURNED LEFT (NORTHEAST) OFF OF DARLINGTON AND WAS ATTEMPTING TO ENTER INTO THE STRAIGHT LANE WHEN UNIT 2 CAME FROM OUT OF NOWHERE STRIKING UNIT 2. DRIVER OF UNIT 2 STATED THAT TRAFFIC WAS CLEAR AND THAT SHE DID NOT SEE WHERE UNIT 1 CAME FROM.
