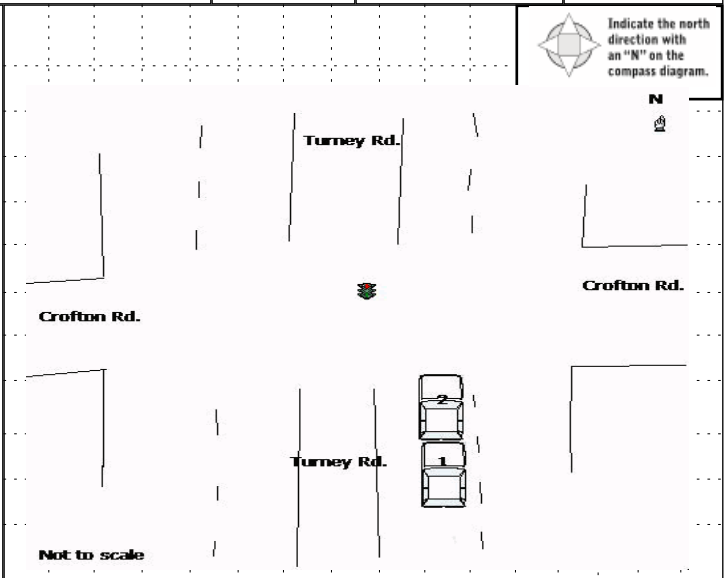

NARRATIVE

THE DRIVER OF UNIT 2 WAS STOPPED NORTHBOUND ON TURNEY RD. AND CROFTON RD. TRAFFIC LIGHT WHEN THE DRIVER OF UNIT 1 FAILED TO MAINTAIN ASSURED CLEAR DISTANCE AHEAD AND STRUCK UNIT 2 IN THE REAR WITH UNIT 1'S FRONT BUMPER. THE DRIVER OF UNIT 1 STATED SHE WAS TRAVELING NORTHBOUND ON TURNEY RD APPROACHING TRAFFIC LIGHT AT CROFTON RD. WHEN SHE DID NOT REACT IN TIME AND STRUCK UNIT 2 IN THE REAR. UNIT 1 WAS CITED FOR FAILURE TO MAINTAIN ACDA.

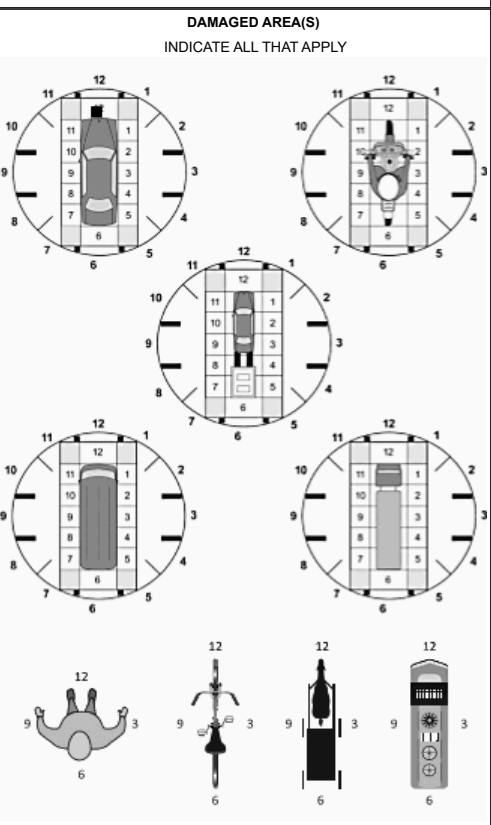
