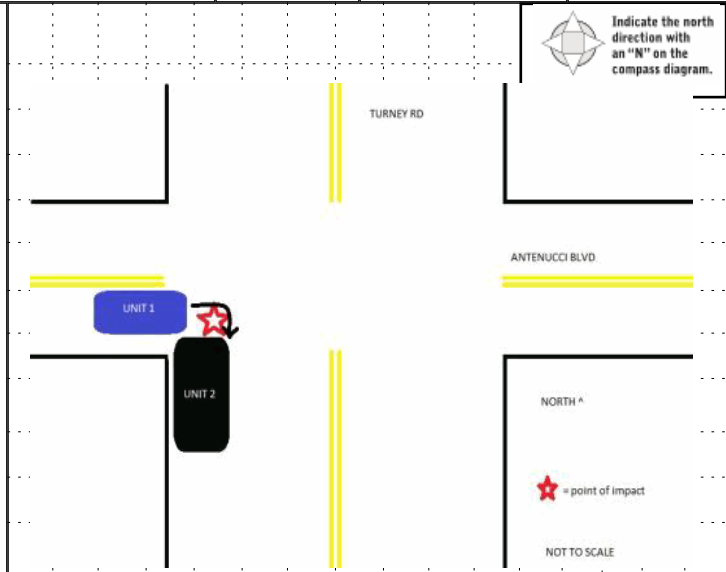

DRIVER OF UNIT #1 STATED HE WAS MAKING A RIGHT TURN FROM ANTENUCCI TO TURNEY RD WHEN UNIT #2, WHICH WAS AHEAD OF HIM, SUDDENLY STOPPED. UNIT #1 SUBSEQUENTLY STRUCK UNIT #2 IN THE LEFT REAR WITH THE RIGHT FRONT OF UNIT #1.

DRIVER OF UNIT #2 STATED SHE WAS MAKING A RIGHT TURN FROM ANTENUCCI TO TURNEY RD WHEN UNIT #1 SUDDENLY STRUCK HER IN THE LEFT REAR, CAUSING MINOR DAMAGE.
