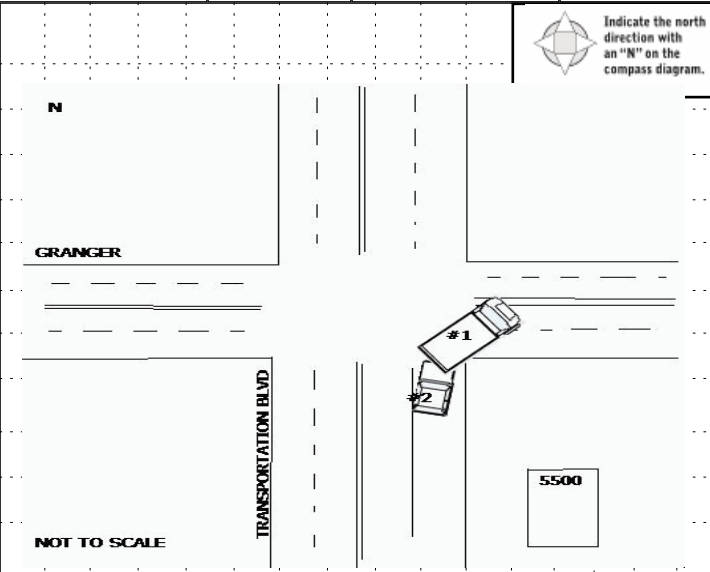

DRIVER OF UNIT #2 STATED HE WAS SLOWING DOWN TO MAKE A RIGHT HAND TURN BEHIND UNIT #1. BUT DUE TO THE WET SLIPPERY ROAD UNIT #2 SLID AND STRUCK THE REAR OF UNIT #1. UNIT #2 SUSTAINED A BROKEN FRONT WINDSHIELD ON THE PASSENGER SIDE FROM THE METAL BAR ON THE REAR OF UNIT #1
