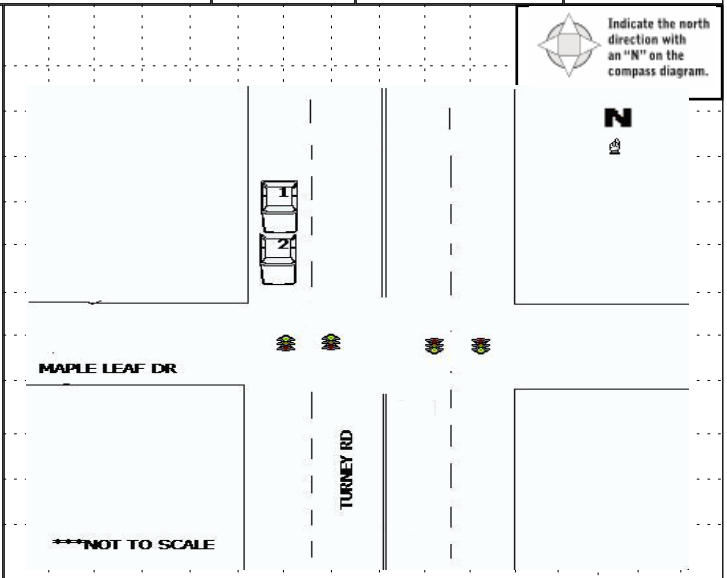

UNIT 2 WAS TRAVELING S/B ON TURNEY RD IN THE CURB LANE AND STOPPED NEAR MAPLE LEAF DR FOR A PEDESTRIAN CROSSING THE ROADWAY. UNIT 1 WAS TRAVELING BEHIND UNIT 2 AND FAILED TO STOP IN TIME AND STRUCK THE REAR OF UNIT 2. DRIVER OF UNIT 2 COMPLAINED OF A BACK INJURY AND WAS TRANSPORTED TO MARYMOUNT HOSPITAL. PASSENGER OF UNIT 1 COMPLAINED OF KNEE AND CHEST PAIN BUT REFUSED TREATMENT ON SCENE.

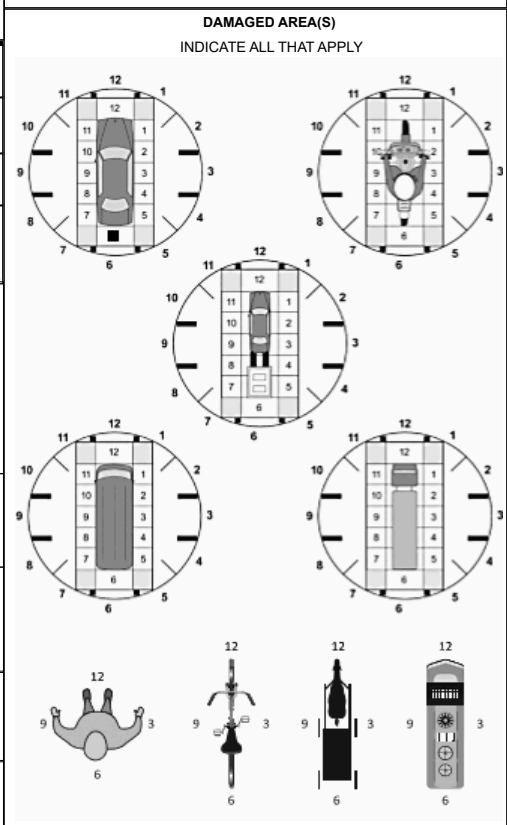
