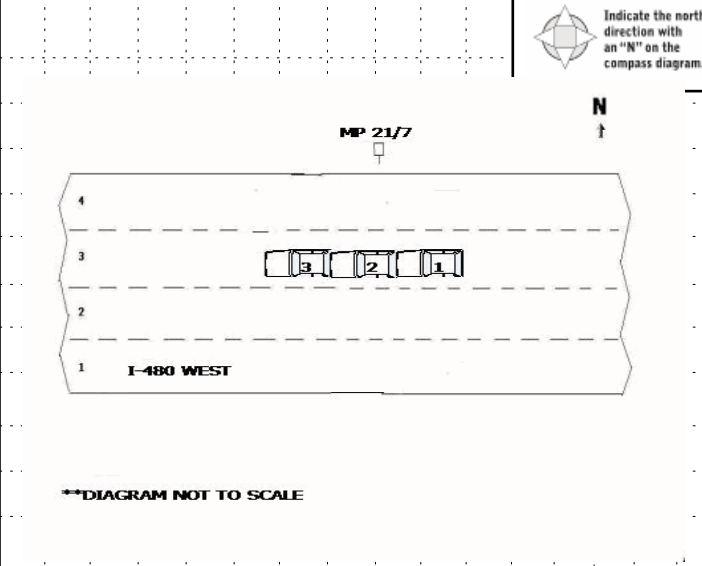

 UNIT 3 STOPPED FOR TRAFFIC IN LANE 3 ON I-480 WEST NEAR MILE POST 21/7. UNIT 2 WAS BEHIND UNIT 3 AND WAS COMING TO A STOP WHEN UNIT 1 STRUCK THE REAR OF UNIT 2. THE FORCE FROM THAT CRASH CAUSED UNIT 2 TO TRAVEL FORWARD AND STRIKE THE REAR OF UNIT 3. UNIT 1 WAS TRAVELING IN LANE 3 BEHIND UNIT 2 AND FAILED TO STOP IN TIME AND STRUCK THE REAR OF UNIT 2. UPON POLICE ARRIVAL, UNIT 1 WAS STOPPED IN LANE 3 OF I-480 WEST AND UNITS 2 AND 3 WERE PULLED OVER ON THE RIGHT SHOULDER APPROXIMATELY 1000 FT AHEAD.
