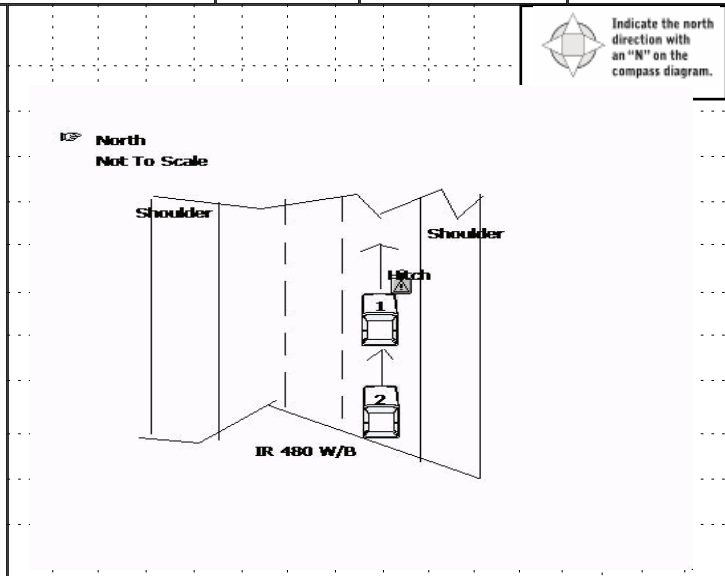

UNIT # 1 WAS TRAVELING WEST NEAR MILE POST 24.0 ON IR 480 IN THE OUTSIDE LANE DIRECTLY IN FRONT OF UNIT # 2. A MOVABLE OBJECT WAS IN THE ROADWAY. AS A RESULT, THE RIGHT FRONT AND RIGHT BACK TIRES ON BOTH UNITS STRUCK THE OBJECT. BOTH UNITS WERE PARKED ON NORTH SHOULDER OF IR 480 UPON ARRIVAL.  
NOTE: BWC - ODOT WORKER LOCATED A TRAILER HITCH IN ROADWAY AND WAS ABLE TO REMOVE HITCH.
