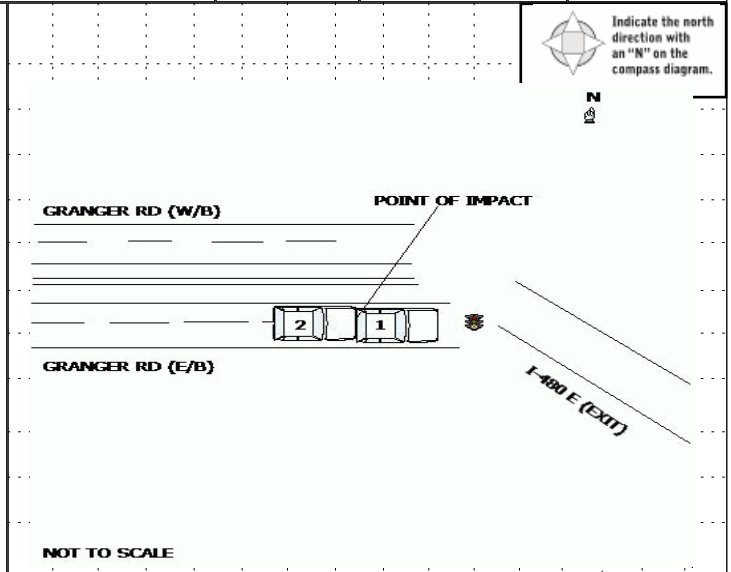

THE DRIVER OF UNIT #1 EXITED THE VEHICLE WHILE THE PASSENGER REMAINED INSIDE. DURING THIS TIME, UNIT #2 WHO WAS BEHIND UNIT #1 ATTEMPTED TO STOP, BUT STRUCK UNIT #1.
