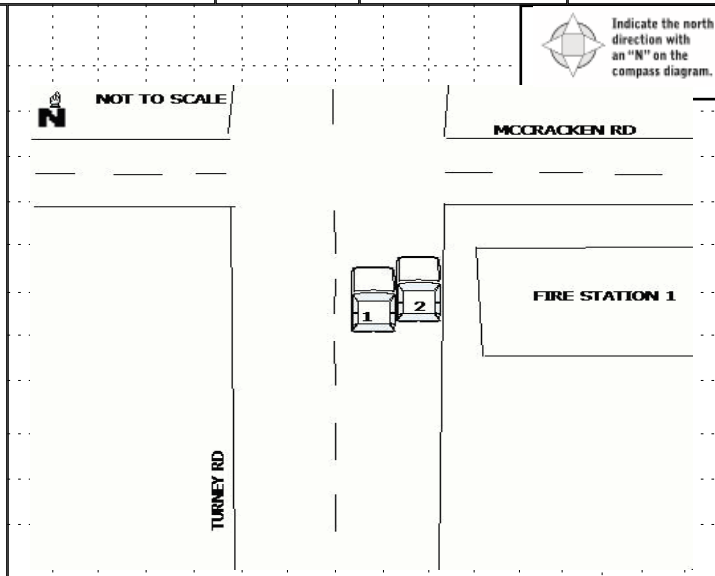

UNIT 1 MADE A LANE CHANGE INTO THE OUTSIDE LANE, AT WHICH TIME, UNIT 1 STRUCK UNIT 2 ON THE DRIVER SIDE FRONT FENDER/BUMPER. MINOR DAMAGE WAS OBSERVED AND BOTH DRIVERS EXCHANGED INFORMATION.
