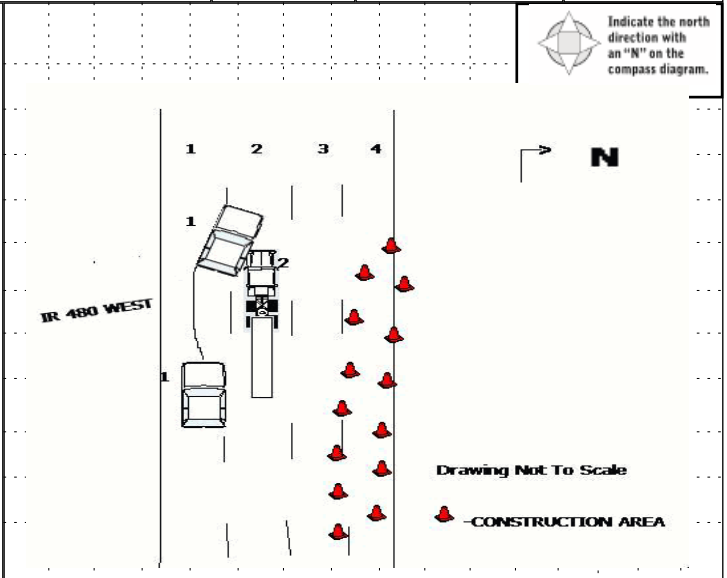

UNITS 1 AND 2 WERE TRAVELING WEST BOUND ON I 480 NEAR THE BROADWAY AVENUE EXIT. UNIT 1 MADE AN IMPROPER LANE CHANGE ATTEMPTING TO EXIT OFF THE HIGHWAY AND STRUCK UNIT 2 IN THE FRONT CAUSING DISABLING DAMAGE TO BOTH UNITS. OPERATOR OF UNIT 1 WAS FOUND TO BE INTOXICATED.
