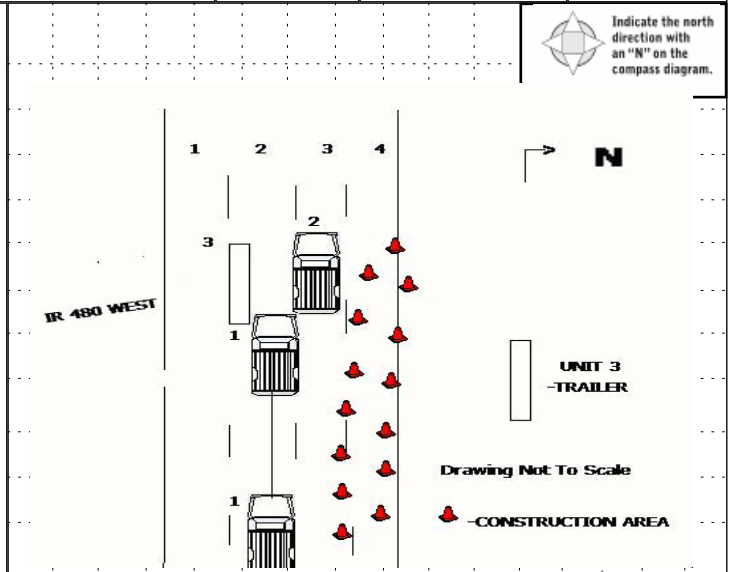

UNIT 1 WAS TRAVELING WEST BOUND ON I 480 NEAR THE BROADWAY AVENUE EXIT RAMP. UNIT 2 AND 3 WERE STATIONARY ON I 480 IN BETWEEN CONSTRUCTION BARRIERS. UNIT 1 FAILED TO SLOW / STOP FOR THE CONSTRUCTION AREA AND RAMMED INTO BOTH UNIT 2 AND 3 CAUSING DAMAGE. UNITS 1 AND 3 ARE DISABLED.
