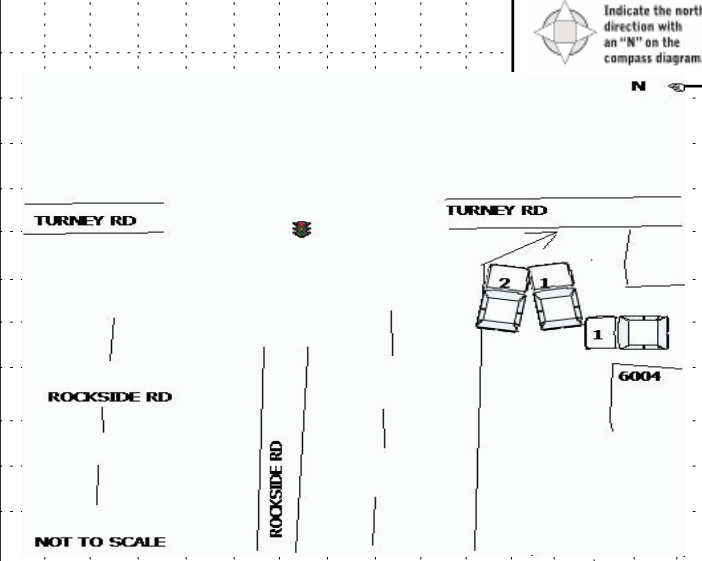

THE DRIVER OF UNIT 1 CHANGED HER VERSION OF HOW THE ACCIDENT OCCURRED. UNIT 1 STATED THE DRIVER OF UNIT 2 STRUCK HER VEHICLE WHICH SHE HAD ALREADY PARKED UNOCCUPIED AT THE GAS PUMP (6004 ROCKSIDE RD.). UNIT 1 STATED SHE LEFT THE SCENE SINCE IT WAS A MINOR DAMAGE.
