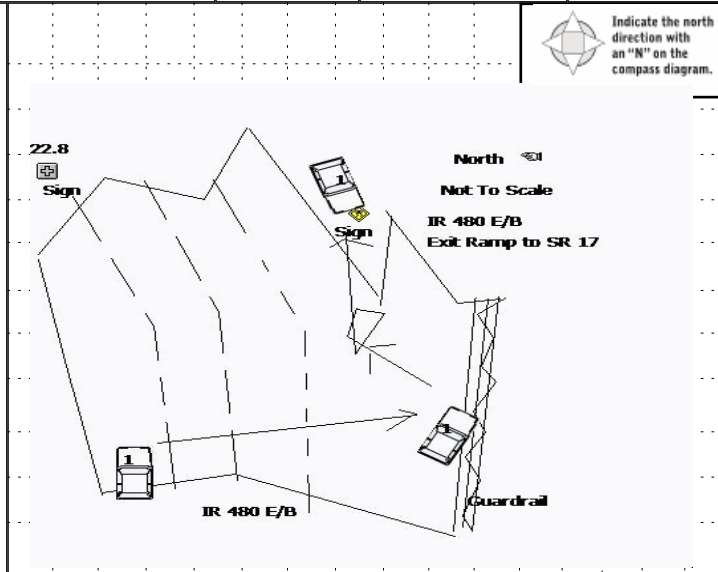

UNIT # 1 WAS TRAVELING EAST ON IR 480 NEAR MILE POST 22.8 IN THE INSIDE LANE. UNIT # 1 FAILED TO MAINTAIN CONTROL. AS A RESULT, UNIT # 1 TRAVELED THROUGH THE MIDDLE INSIDE, MIDDLE, MIDDLE OUTSIDE, OUTSIDE LANES AND INTO THE SOUTH SHOULDER COLLIDING WITH THE GUARD RAIL. UNIT # 1 THEN ROTATED IN A COUNTER CLOCKWISE DIRECTION AND CONTINUED IN AN EASTERN DIRECTION. UNIT # 1 THEN TRAVELED OFF ROAD BETWEEN THE OFF RAMP AND EASTBOUND LANES OF TRAVEL COLLIDING WITH A TRAFFIC SIGN. UNIT # 1 WAS AT FINAL REST FACING WESTWARD UPON
