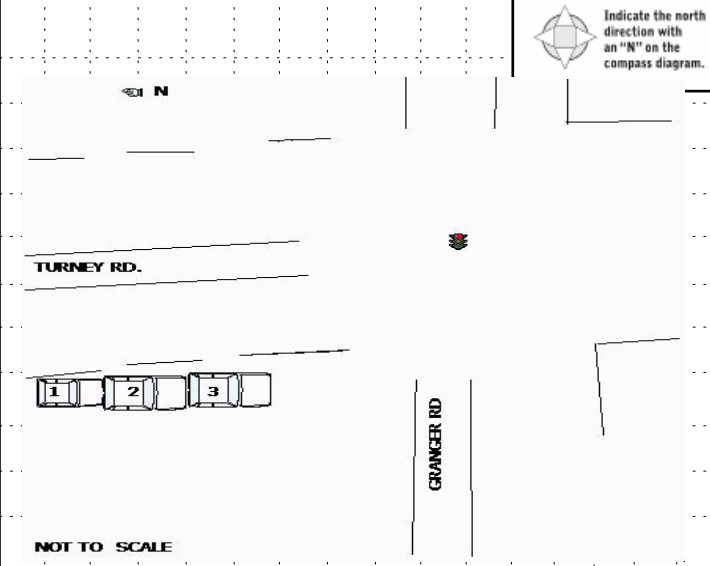

NARRATIVE

THE DRIVER OF UNIT 1 WAS TRAVELING SOUTHBOUND ON TURNEY RD DIRECTLY BEHIND UNIT 2 WHO STOPPED FOR TRAFFIC WHEN UNIT 1 STRUCK THE REAR OF UNIT 2. DUE TO UNIT 1'S IMPACT, UNIT 2 THEN STRUCK THE REAR OF UNIT 3 WHO WAS STOPPED IN TRAFFIC. THE DRIVER OF UNIT 1 WAS ISSUED A CITATION FOR FAILED TO MAINTAIN ASSURED CLEAR DISTANCE AHEAD. THE CRASH OCCURRED IN THE RIGHT LANE.
