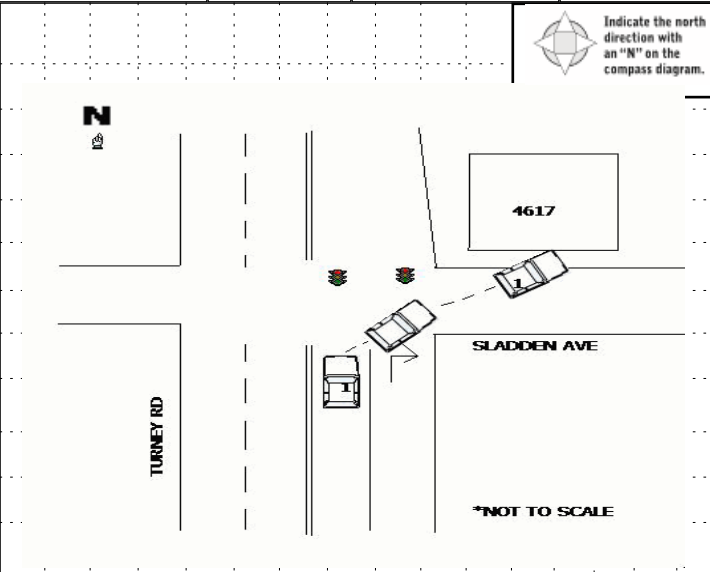

UNIT 1 WAS TRAVELING N/B ON TURNERY RD AND MADE A RIGHT TURN THROUGH THE RED LIGHT AT SLADDEN AVE FROM THE LEFT LANE. UNIT 1 DROVE ACROSS SLADDEN AVE AND OFF THE ROADWAY TO THE LEFT, WHERE IT STRUCK THE BUILDING (4617 TURNERY) AND CAME TO REST. ALL OCCUPANTS COMPLAINED OF MINOR INJURIES BUT ONLY THE FRONT PASSENGER WAS TRANSPORTED TO THE HOSPITAL. UNIT 1 WAS TOWED FROM SCENE. VERY MINOR DAMAGE TO BUILDING.
