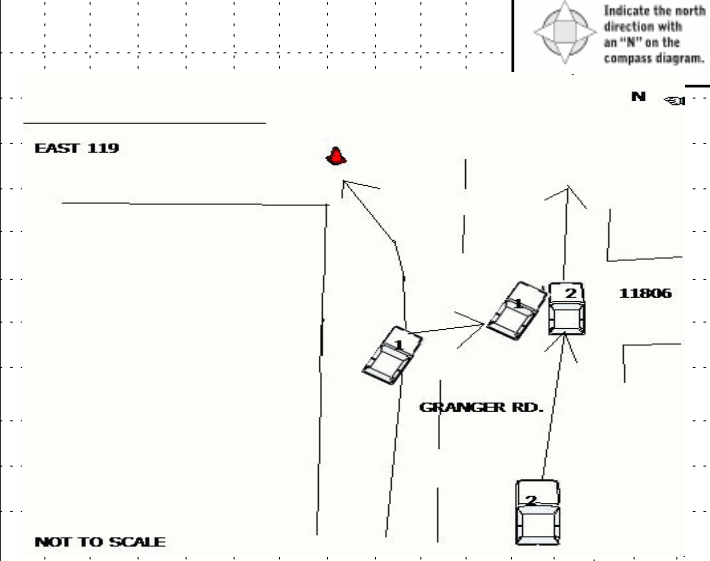

DRIVER OF UNIT 1 WAS TRAVELING E/B ON GRANGER RD MAKING RIGHT TURN FROM THE LEFT LANE TURN ONLY AND ATTEMPTED TO CROSS THE CURB LANE INTO THE DRIVEWAY OF (11806) AND STRUCK UNIT 2 IN THE LEFT FRONT WITH UNIT 1'S FRONT RIGHT. WHO WAS TRAVELING STRAIGHT E/B ON GRANGER ROAD IN THE CURB LANE APPROACHING EAST 119 STREET INTERSECTION. UNIT 2 STATED UNIT 1 MADE IMPROPER TURN FROM THE LEFT LANE TURN ONLY INTO THE CURB LANE AND STRUCK HER VEHICLE WHILE ATTEMPTING TO PULL INTO 11806'S DRIVEWAY.
