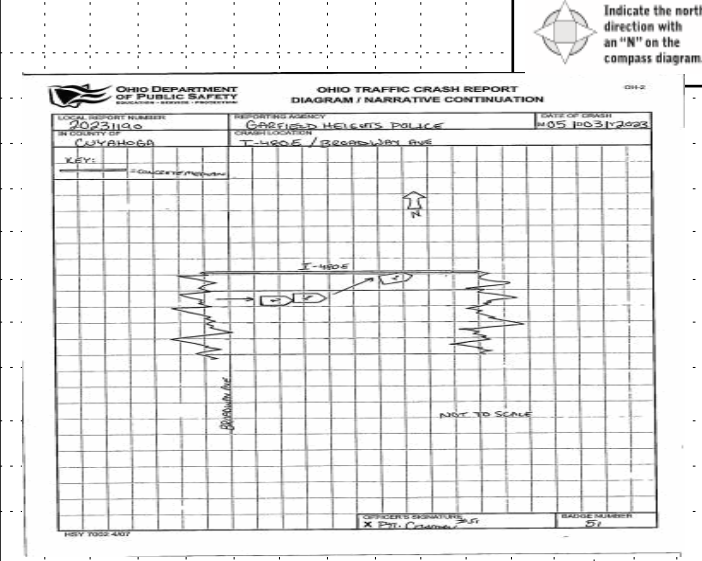

UNIT 2 DRIVER STRUCK UNIT 1 IN THE REAR RIGHT BUMPER WITH ITS FRONT LEFT BUMPER. UNIT 1 THEN GRAZED THE RAISED MEDIAN WITH ITS FRONT LEFT BUMPER.
