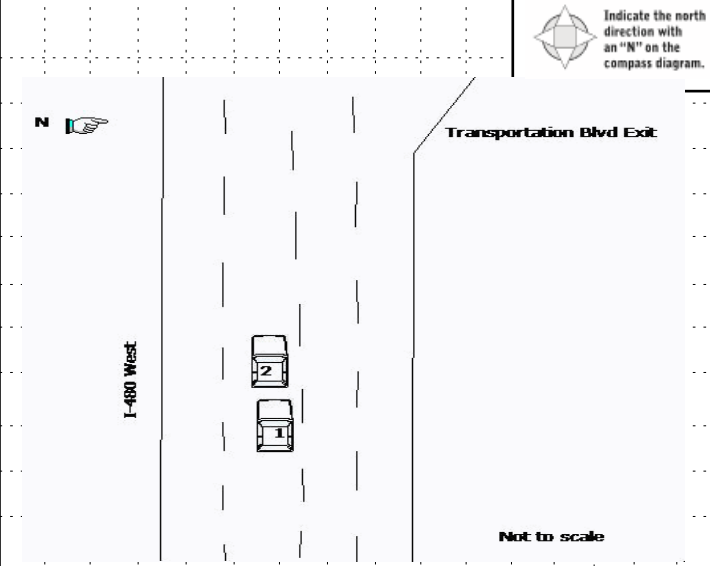

UNIT #2 WAS TRAVELING WEST ON I-480 W AND CAME TO A STOP IN THE ROADWAY DUE TO CONSTRUCTION WORK ON THE HIGHWAY. UNIT #1, WHO WAS ALSO TRAVELING WEST ON I-480 W, STATED HE WAS NOT PAYING ATTENTION AND REAR ENDED UNIT #2 AT APPROXIMATELY 50MPH. THE IMPACT OF THE ACCIDENT CAUSED UNIT #2 TO CATCH ON FIRE RESULTING IN A TOTAL BURNOUT.
