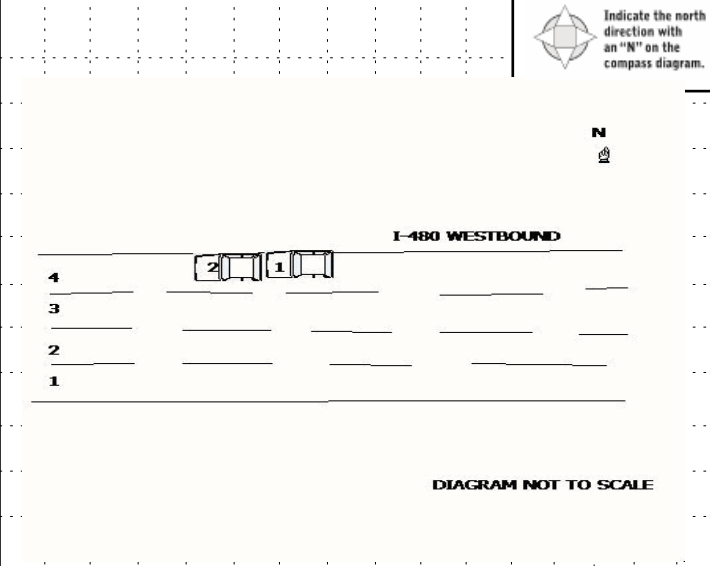

UNIT 2 WAS TRAVELING ON I-480 (WESTBOUND) IN THE NUMBER FOUR LANE. UNIT 2 BEGAN TO HAVE MECHANICAL PROBLEMS. UNIT 1 WAS ALSO TRAVELING ON I-480 (WESTBOUND) IN THE NUMBER FOUR LANE AND WAS APPROACHING BEHIND UNIT 2. UNIT 1 STRUCK UNIT 2 CAUSING BOTH UNITS TO BECOME DISABLED IN THE MIDDLE OF THE ROADWAY.
