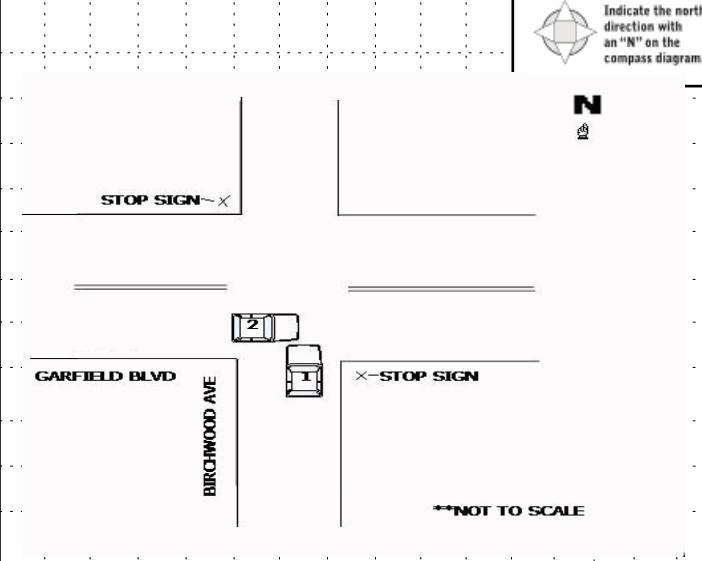

UNIT 1 STOPPED AT THE STOP SIGN ON BIRCHWOOD AVE AT GARFIELD BLVD. UNIT 1 THEN DROVE STRAIGHT INTO THE INTERSECTION AND FAILED TO YIELD TO UNIT 2, WHICH WAS TRAVELING E/B ON GARFIELD BLVD. UNIT 1 STRUCK THE RIGHT FRONT OF UNIT 2. BOTH UNITS DROVE TO DRIVER OF UNIT 1'S ADDRESS AFTER THE CRASH. NO INJURIES REPORTED.
