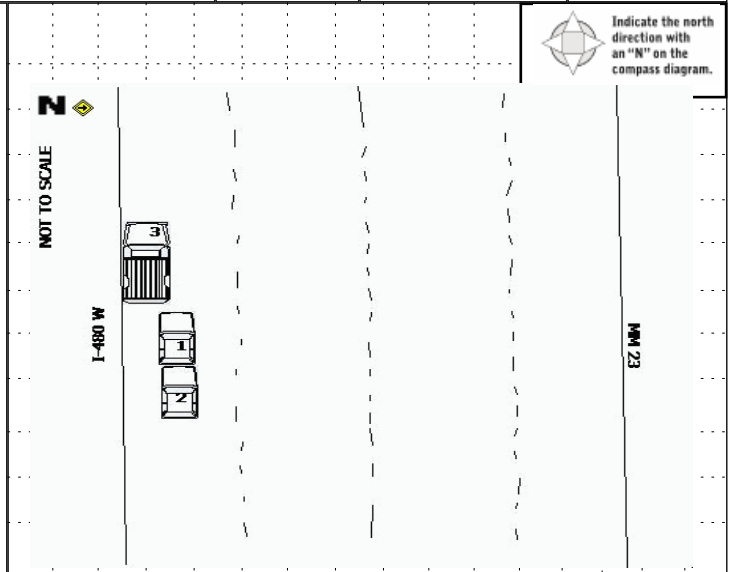

UNITS 1 AND 2 WERE TRAVELING WESTBOUND ON 1-480W NEAR MM 23, IN THE LEFT MOST LANE, ENTERING THE CONSTRUCTION ZONE THAT IS CURRENTLY IN PLACE. THE DRIVER OF UNIT 1 STATED THAT A CONSTRUCTION VEHICLE HAULING CONES ENTERED THE ROADWAY, CAUSING UNIT 1 TO BRAKE HARD, IN TURN CAUSING UNIT 2 TO BRAKE HARD AND STRIKE THE REAR OF UNIT 1.

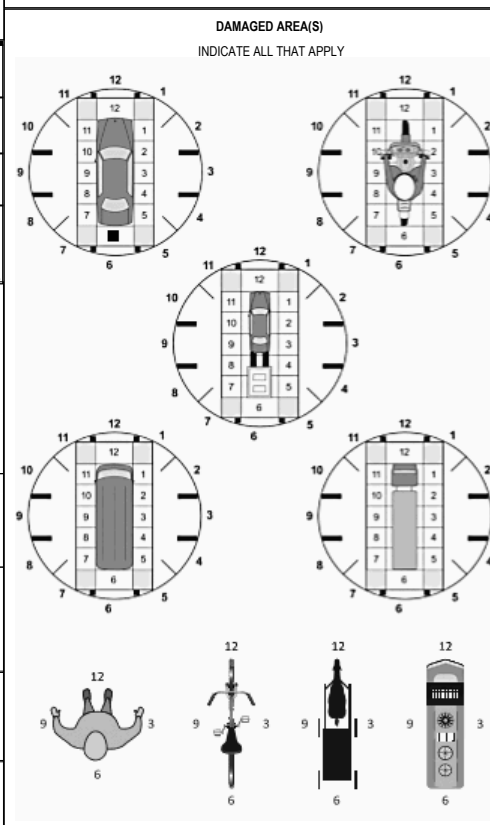


