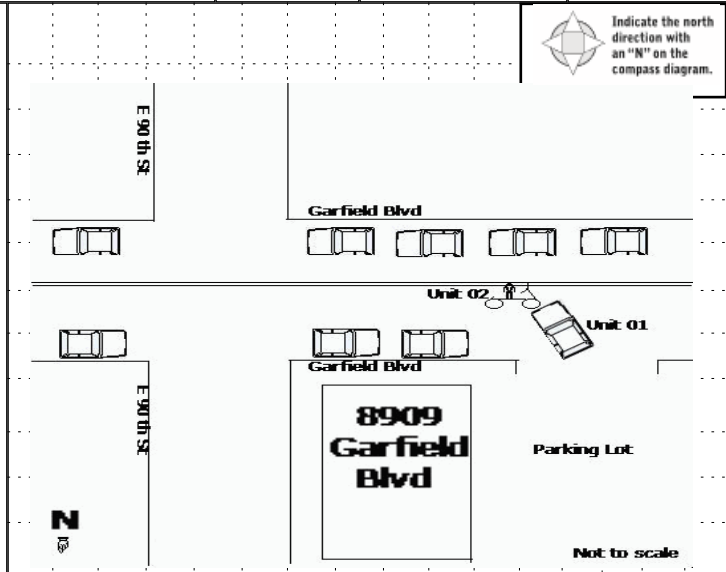

 UNIT 1 ATTEMPTED TO PULL SOUTH AND MAKE A LEFT/EAST TURN OUT OF THE PARKING LOT OF 8909 GARFIELD BLVD WITH AN OBSTRUCTED VIEW FROM NUMEROUS PARKED VEHICLES ON THE STREET. THE DRIVER OF UNIT 1 STATED SHE THEN STOPPED FOR AN UNKNOWN VEHICLE THAT WAS TRAVELING WEST TOWARD HER ON GARFIELD BLVD AT A HIGH RATE OF SPEED. THE DRIVER OF UNIT 1 STATED THE SPEEDING VEHICLE THEN SUDDENLY STOPPED AND WENT AROUND HER WHILE UNIT 2 ALSO TRAVELING WEST WAS FOLLOWING TOO CLOSELY AND OUT OF VIEW BEHIND THE SPEEDING VEHICLE.
