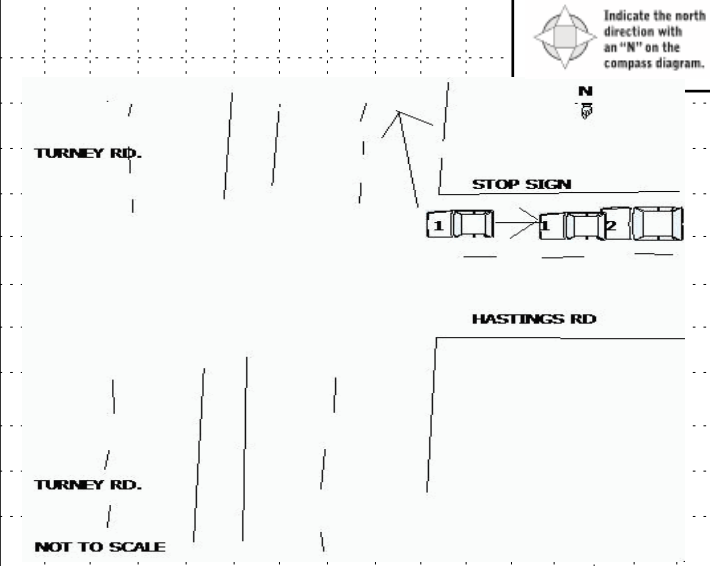

THE DRIVER OF UNIT 2 WAS STOPPED DIRECTLY BEHIND UNIT 1 AT STOP SIGN E/B ON HASTINGS WAITING FOR UNIT 1 TO TURN ONTO TURNEY RD. THE DRIVER OF UNIT 1 PULLED UP AND THEN PLACED THE VEHICLE IN REVERSE AND STRUCK UNIT 2 IN THE FRONT LEFT WITH UNIT 1'S REAR BUMPER. UNIT 1 LEFT THE SCENE OF ACCIDENT WITHOUT STOPPING.

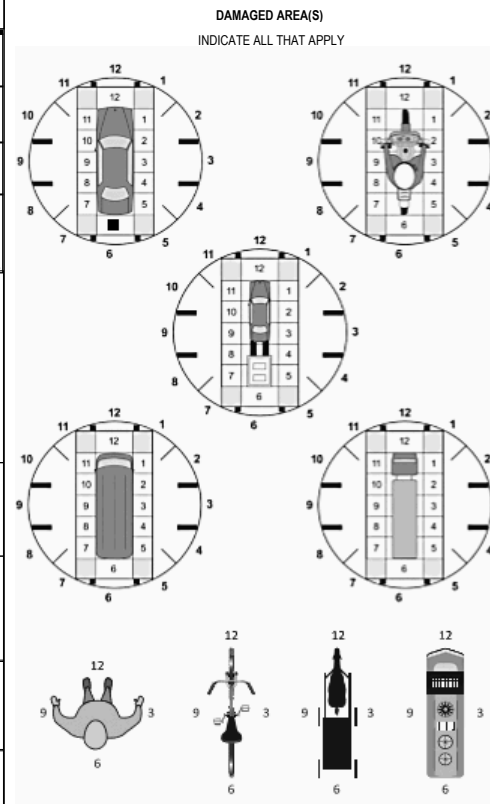

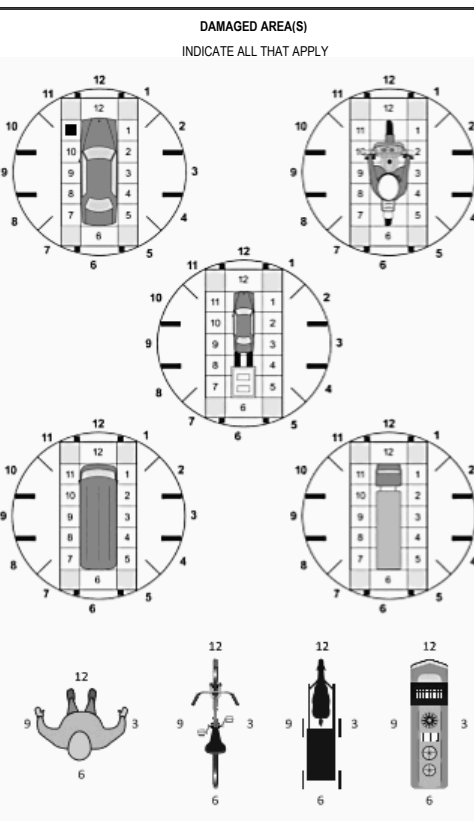
