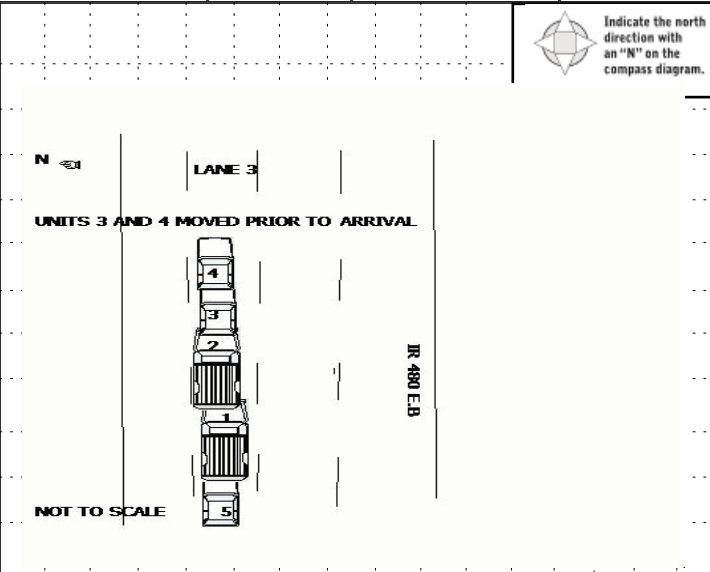

UNIT 5 THEN CHANGED LANES TO LANE #3 AND WAS UNABLE TO STOP IN TIME AND STRUCK UNIT 1 IN REAR WHEN UNIT 1 STOPPED IN TRAFFIC. FORCING UNIT 1 TO STRIKE UNIT 2 IN REAR. FORCING UNIT 2 TO STRIKE UNIT 3 IN THE REAR AND FORCING UNIT 3 TO STRIKE UNIT 4 IN REAR.
