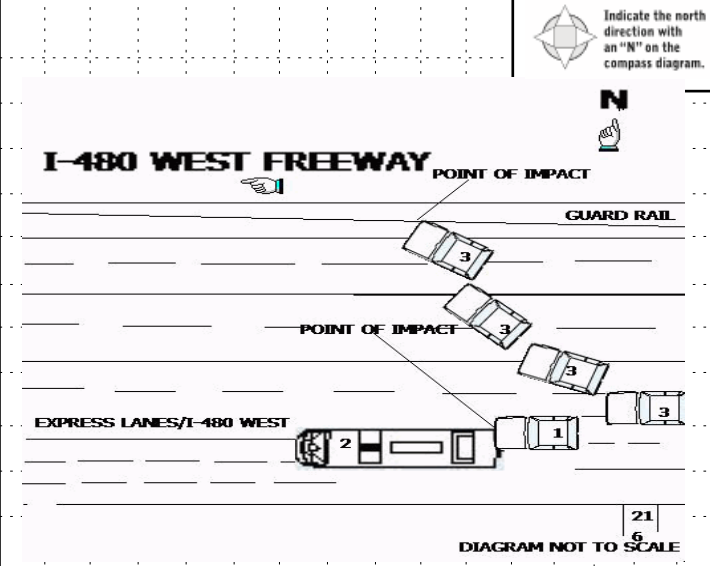

NARRATIVE

WHILE UNIT # 2 WAS PARKED/MOVING AT A SLOW RATE OF SPEED, CONDUCTING ROAD WORK IN LANE ONE ON I-480 WEST HIGHWAY, NEAR MILE POST 21/6 AND THE EXPRESS LANES. UNIT # 1 WAS TRAVELING ON I-480 W/B APPROACHING THE EXPRESS LANES IN LANE ONE. UNIT # 1 STRUCK THE REAR BACK END OF UNIT # 2 CAUSING DAMAGE TO BOTH VEHICLES. UNIT # 3 WAS ALSO TRAVELING ON I-480 W/B IN THE NUMBER ONE LANE, AND SWERVED OFF TO THE RIGHT OF THE HIGHWAY TO AVOID CRASHING INTO UNIT # 1 AND CRASHED INTO THE GUARD RAIL.


