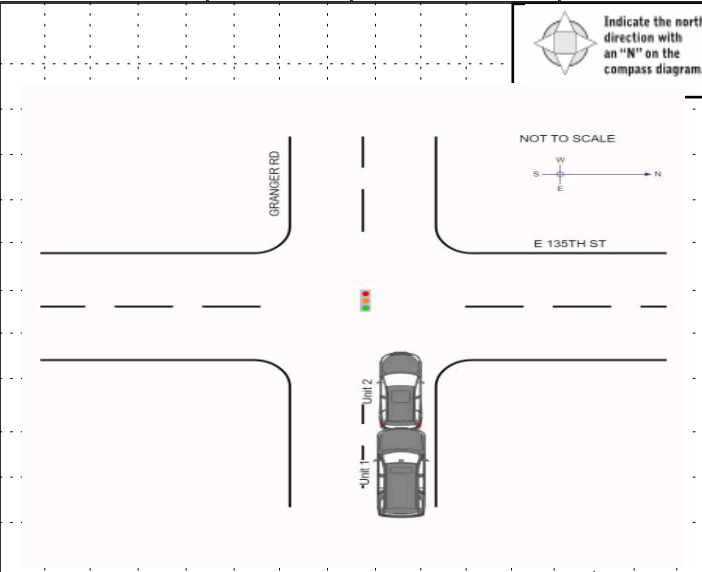

DRIVER OF UNIT 2 ARRIVED ON STATION STATING THAT SHE WAS TRAVELING WESTBOUND ON GRANGER RD AT THE INTERSECTION OF E 135TH ST STOPPED AT THE TRAFFIC LIGHT. WHEN THE LIGHT TURNED GREEN, UNIT 1 ACCELERATED INTO THE REAR OF UNIT 2 CAUSING MINOR DAMAGE TO THE REAR BUMPER. BOTH DRIVERS EXCHANGED INFORMATION HOWEVER, THE DRIVER OF UNIT 1 STATED THAT HE HAD THE GENERAL INSURANCE, BUT DID NOT PROVIDE PROOF. THE DRIVER OF UNIT 1 STATED THAT HE WOULD PAY OUT OF POCKET FOR THE DAMAGE AND THEN LEFT THE SCENE.
