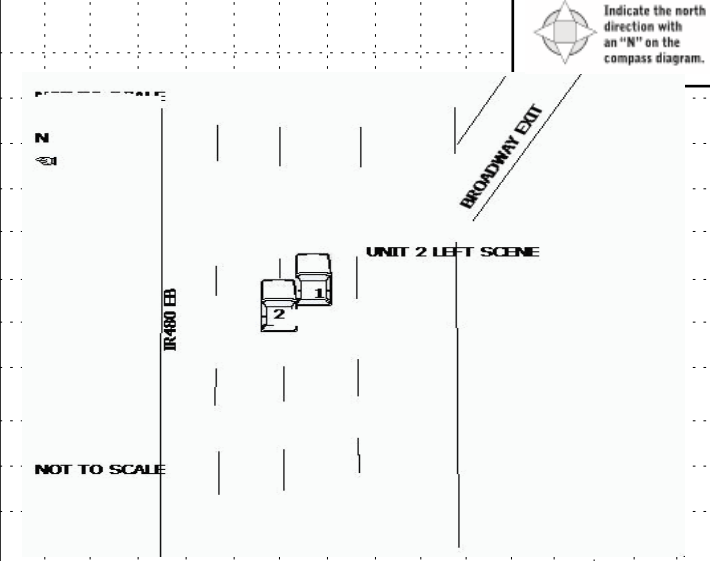

UNIT 1 STATES WHILE E/B ON IR480 AT BROADWAY IN LANE 2, UNIT 2 ATTEMPTED TO CHANGE LANES FROM LANE 3 TO LANE 2 AND FAILED TO YIELD TO UNIT 1 CAUSING UNIT 2 TO STRIKE UNIT 1 ON DRIVER'S SIDE. UNIT 2 DRIVER FAILED TO IDENTIFY HIMSELF AND ADVISED HE HAD NO INSURANCE AND OFFERED \$300. UNIT 2 THEN FLED THE SCENE. UNIT 1 DRIVER WAS ABLE TO TAKE PICTURE OF UNIT 2 LICENSE PLATE.
