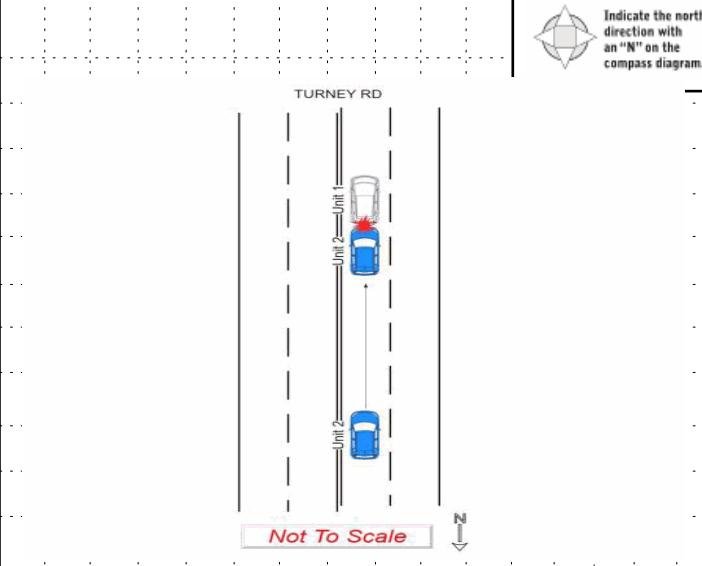

DRIVER OF UNIT 1 WAS TRAVELING SOUTH ON TURNEY RD IN THE LEFT LANE. DRIVER OF UNIT 1 STATED SHE OBSERVED TRAFFIC AHEAD STOP, UNIT 1 STOPPED AND WAS SUDDENLY STRUCK IN THE CENTER REAR BY UNIT 2. DRIVER OF UNIT 2 WAS TRAVELING SOUTH ON TURNEY RD IN THE LEFT LANE. DRIVER OF UNIT 2 STATED HE LOOKED DOWN TO CHECK HIS TRAVELING SPEED AND WHEN LOOKING UP, HE OBSERVED UNIT 1 STOPPED.
