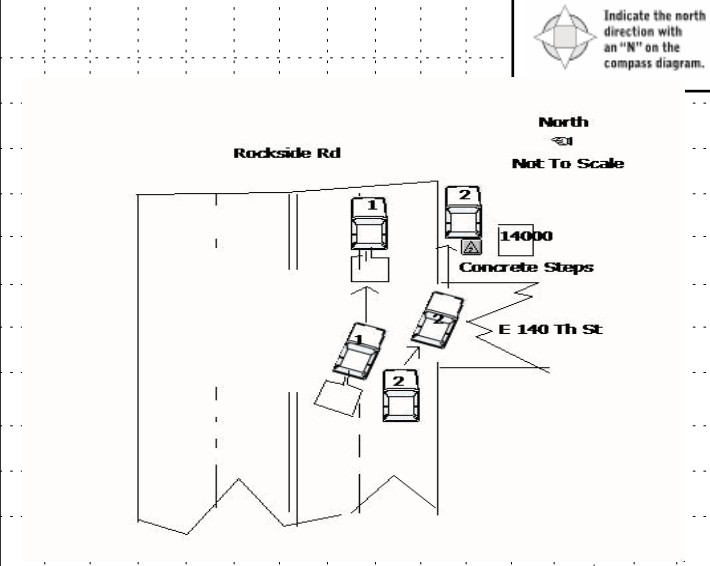

UNIT # 1 TRAVELED INTO THE OUTSIDE LANE. AS A RESULT, UNIT # 2 TOOK EVASIVE ACTION TO THE RIGHT AND STRUCK THE CURB. UNIT # 2 CONTINUED IN AN EASTERN DIRECTION OFF THE ROAD, COLLIDING WITH CONCRETE STEPS AND COMING TO FINAL REST AFTER TRAVELING OVER THE STEPS. UNIT # 1 LEFT THE SCENE EASTBOUND ON ROCKSIDE RD.
