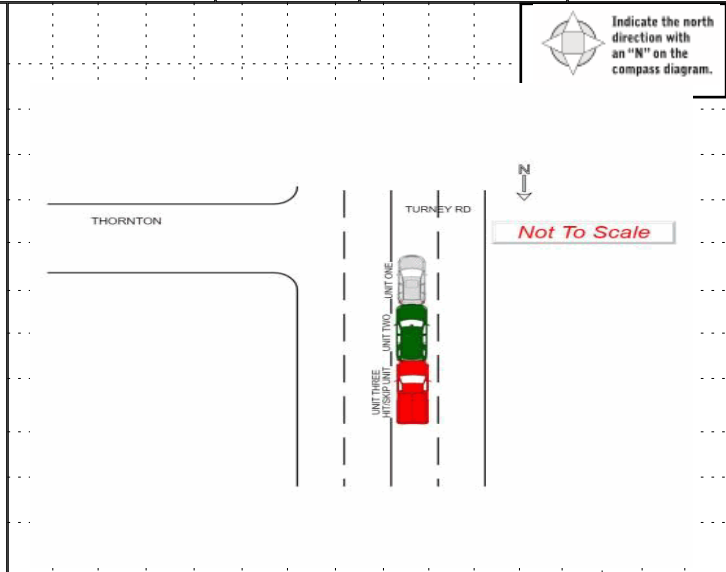

UNIT ONE WAS STOPPING ON TURNEY RD ATTEMPTING TO MAKE A LEFT TURN ON TO THORNTON RD. UNIT TWO WAS SLOWING BEHIND UNIT ONE TRAVELING SOUTH ON TURNEY RD. UNIT THREE WAS TRAVELING SOUTH ON TURNEY RD, STRUCK UNIT TWO, AND UNIT TWO STRUCK UNIT ONE. UNIT ONE SUFFERED MINOR DAMAGE AND UNIT TWO SUFFERED FUNCTIONAL DAMAGE. UNIT THREE FLED THE SCENE AND THE ONLY DESCRIPTION WAS IT WAS A RED FORD PICK-UP TRUCK. UNIT THREE WAS UNABLE TO BE LOCATED AT THIS TIME.
